3 **Resolution approving the Fiscal Year (FY) 2026-2027 Emergency Solutions Grants**  
4 **(ESG) Program; and authorizing the Mayor, on behalf of the City and County of San**  
5 **Francisco, to apply for, accept, and expend the City’s FY2026-2027 ESG Program**  
6 **entitlement from the United States Department of Housing and Urban Development, in**  
7 **the amount of \$1,712,613 for an unspecified period starting July 1, 2026.**

9 WHEREAS, Under the Stewart B. McKinney Homeless Assistance Act and Cranston  
10 Gonzalez National Affordable Housing Act of 1990, the Secretary of the United States  
11 Department of Housing and Urban Development (HUD) is authorized to make a grant to the  
12 City and County of San Francisco under the Emergency Solutions Grants Program (ESG);  
13 and

14 WHEREAS, The City and County of San Francisco anticipates receiving \$1,712,613 in  
15 FY2026-2027 ESG Program funds from HUD; and

16 WHEREAS, The Citizen’s Committee on Community Development (CCCD) has  
17 prepared recommendations for ESG funding as set forth in a proposed Expenditure Schedule,  
18 a copy of which is located in Clerk of the Board of Supervisors File No. 260370; and

19 WHEREAS, The ESG Program funds will be used to provide for the payment of certain  
20 operating and social service expenses in connection with emergency shelters and for  
21 homeless prevention activities; and

22 WHEREAS, The proposed grant does not require an Annual Salary Ordinance  
23 amendment; and

24 WHEREAS, Receipt of the ESG funds requires the City to match 100% of funds  
25 provided by HUD; and

1           WHEREAS, The funding agency (HUD) does not allow use of the grant on indirect  
2 costs; now, therefore, be it

3           RESOLVED, That the Mayor of the City and County of San Francisco is hereby  
4 authorized to apply for, accept, and expend the City's FY2026-2027 ESG Program entitlement  
5 from HUD in accordance with the purposes and goals for the funding as generally set forth in  
6 the 2025-29 Five-Year Consolidated Plan and the Expenditure Schedule; and, be it

7           FURTHER RESOLVED, That the Board of Supervisors does hereby approve the  
8 purposes and goals for FY2026-2027 ESG Program funding as set forth in the Expenditure  
9 Schedule for recipient agencies and departments; and, be it

10          FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
11 indirect costs in the grant budget; and, be it

12          FURTHER RESOLVED, That the Mayor is hereby authorized to enter into and execute  
13 agreements between the City and County of San Francisco and various agencies consistent  
14 with the ESG Program and the Expenditure Schedule; and, be it

15          FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation  
16 and certifications as may be requested or required by HUD, and to take such additional  
17 actions as may be required to apply for, accept and expend the ESG funds consistent with  
18 this Resolution and the goals of the ESG Program and all applicable legal requirements, and  
19 any such actions are solely intended to further the purposes of this Resolution, and are  
20 subject in all respect to the terms of this Resolution, and any such action cannot increase the  
21 risk to the City, or require the City to expend any resources, and that the Mayor shall consult  
22 with the City Attorney prior to execution and provided that within 30 days of the agreements  
23 approved by this Resolution being executed by all parties, such final documents (showing  
24 marked changes, if any) shall be provided to the Clerk of the Board, for inclusion in the official  
25

1 file, together with a brief explanation of any actions from the date of the adoption of this  
2 Resolution; and, be it

3 FURTHER RESOLVED, That all actions heretofore taken by the officers of the City  
4 with respect to the application for, or the acceptance or expenditure of, ESG funds, as



## BACKGROUND

- Each year, the City receives four entitlement grants from the U.S. Department of Housing and Urban Development (HUD)
  - Community Development Block Grant (CDBG)
  - Emergency Solutions Grant (ESG)
  - Home Investment Partnerships (HOME)
  - Housing Opportunities for Persons With AIDS (HOPWA)
- Entitlement grants are based on statutory formulas
- Amounts in these resolutions are estimates based on FY25-26 amounts. Actual awards are less than 5% different from estimates.
- MOHCD is the lead agency for receiving HUD entitlement grants
- Funding is administered by MOHCD, OEWD, and HSH

# Investments with HUD Funding

- **Protects Housing Stability**  
Provides essential support that helps low-income families, seniors, and vulnerable residents remain safely housed.
- **Expands Affordable Housing**  
Invests in creating and preserving long-term affordable homes across San Francisco.
- **Strengthens Community Services**  
Funds neighborhood-based nonprofits delivering prevention, case management, legal help, youth programs, and home repairs.
- **Reduces Homelessness**  
Supports emergency shelter, rapid rehousing, and services that help people transition from crisis to stability.
- **Improves Health & Well -Being**  
Ensures residents with complex needs, including people living with HIV/AIDS, receive stable housing and care.
- **Maximizes Local Resources**  
Brings federal dollars into San Francisco, reducing reliance on the City's General Fund and leveraging partnerships for greater impact.
