7 MOVED, That the Board of Supervisors of the City and County of San Francisco does
8 hereby appoint the hereinafter designated persons to serve as members of the Eastern
9 Neighborhoods Citizens Advisory Committee, pursuant to the provisions in the San Francisco
10 Administrative Code Chapter 10E., for the terms specified:

11 Keith Goldstein, seat 1, new appointment, must be nominated by District 10 Supervisor
12 and confirmed by the full Board for term to be determined by lot.

13 Eric Smith, seat 2, new appointment, must be nominated by District 10 Supervisor and
14 confirmed by the full Board for term to be determined by lot.

15 Susan Eslick, seat 3, new appointment, must be nominated by District 10 Supervisor
16 and confirmed by the full Board for term to be determined by lot.

17 Jared Doumani, seat 4, new appointment, must be nominated by District 10 Supervisor
18 and confirmed by the full Board for term to be determined by lot.

19 Chris Durazo (residency requirement waived), seat 5, new appointment, must be
20 nominated by District 6 Supervisor and confirmed by the full Board for term to be determined
21 by lot.

22 David Ho, seat 6, new appointment, must be nominated by District 6 Supervisor and
23 confirmed by the full Board for term to be determined by lot.

24 Chris Block, seat 7, new appointment, must be nominated by District 8 Supervisor and
25 confirmed by the full Board for term to be determined by lot.

1 Eric Quezada, seat 8, new appointment, must be nominated by District 9 Supervisor
2 and confirmed by the full Board for term to be determined by lot; and, be it

3 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 4 1. The membership of the Eastern Neighborhoods Citizens Advisory Committee has a
5 goal to be representative of the diversity of the City and County of San Francisco.
- 6 2. Applicant Chris Durazo, an appointee, who is not a resident of San Francisco, is a
7 person with experience that uniquely qualifies him to serve on the Eastern
8 Neighborhoods Citizens Advisory Committee.
- 9 3. The Eastern Neighborhoods Citizens Advisory Committee has attempted to fill the
10 position, for which Chris Durazo was nominated, with an individual who is a City
11 resident and who has the specific experience, skills, and qualifications, but has
12 been unable to do so at this time. The Rules Committee has certified that Chris
13 Durazo is qualified to serve on the Eastern Neighborhoods Citizens Advisory
14 Committee.
- 15 4. After exercising due diligence, the Board of Supervisors concludes that there is no
16 other possible representative, who is a resident of San Francisco and who has the
17 specific experience, skills, or qualifications possessed by this applicant, and who is
18 willing to serve on the Eastern Neighborhoods Citizens Advisory Committee at this
19 time; and, be it

20 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
21 for Chris Durazo, as allowed in cases where no qualified City resident, willing to serve, can be
22 found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to
23 boards, commissions, and advisory bodies established by legislative act of the Board of
24 Supervisors to be resident(s) of the City and County of San Francisco.
