2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 21 OFF SALE GENERAL ALCOHOLIC
3 BEVERAGE CONTROL LICENSE FROM 1198 HYDE STREET TO 1496 LARKIN STREET TO THOI CONG
4 NGUYEN FOR LARKIN CORNER MARKET WILL SERVE THE PUBLIC CONVENIENCE AND
5 NECESSITY OF THE PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE
6 WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND PROFESSIONS CODE WITH

9 WHEREAS, Thoi Cong Nguyen is seeking transfer of a Type 21 off-sale general alcoholic beverage
10 control license for Larkin Corner Market located at 1496 Larkin Street; and,

11 WHEREAS, The City Planning Department has verified that the area is properly zoned; and,

12 WHEREAS, The Police Department recommends that the liquor license application be approved with
13 conditions; now, therefore, be it

14 RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code,
15 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that
16 the transfer of a Type 21 off-sale general alcoholic beverage control license from 1198 Hyde Street to 1496 Larkin
17 Street for Thoi Cong Nguyen for Larkin Corner Market, will serve the public convenience and necessity of the
18 people of the City and County of San Francisco.

19 Condition(s): The sale or service of alcoholic beverages shall not be permitted after the hours of 12
20 midnight each day of the week. Licensee shall make a best effort to keep the front of the premise clean, clear, and
21 maintained so as to minimize public nuisance related problems. Licensee shall maintain adequate lighting on the
22 exterior of the premises.
