EXECUTIVE SUMMARY	
Legislative Objectives - The proposed ordinance would appropriate \$3.5 million from the General Reserve to the Mayor's Office of Housing and Community Development (MOHCD) to fund the following in FY 2025-26: (1) \$1.86 million to community-based organizations that provide immigration legal defense, and (2) \$1.64 million to community-based organizations for coordinated response services. Key Points - MOHCD is the primary administrator of the City's grants on immigration legal services to community-based organizations. In FY 2025-26 and FY 2026-27, MOHCD's budget for immigration legal services is \$12,339,016 for each fiscal year, which funds a total of 12 agencies across various program areas. The proposed appropriation will fund the expansion of existing citywide coordinated services for immigration legal defense and response efforts serving immigrant communities. This includes expanded staffing to provide legal consultations and representation, upgraded technology and communications infrastructure, and increased outreach. - MOHCD has not identified specific community-based organizations and programs to be funded, as the Department will determine the procurement approach and funding methodology following approval of the proposed ordinance. Fiscal Impact - The proposed ordinance would appropriate \$3.5 million from the General Reserve to the MOHCD's community-based services accounts, which the Department plans to allocate to legal defense and response services. - Any uses of the General Reserve during the current year (FY 2025-26) will increase the required deposit in the budget year (FY 2026-27) by a like amount. Policy Consideration - We recommend the Mayor's Office consider the following factors when determining funding allocations to service providers: (1) Barriers to access (e.g., linguistic, cultural) impacting service reach, (2) Vulnerable marginalized communities disproportionately impacted by the recent uptick in immigration enforcement, (3) Performance of providers, (4) Capacity of providers and whether funded providers can staff up quickly, and (5) Cost effectiveness and how costs of services compare among providers. Recommendation - Approval of the proposed ordinance is a policy matter for the Board of Supervisors.	

MANDATE STATEMENT

City Charter Section 9.105 states that amendments to the Annual Appropriations Ordinance, after the Controller certifies the availability of funds, are subject to Board of Supervisors approval by ordinance.

BACKGROUND

The Mayor's Office of Housing and Community Development (MOHCD) is the primary administrator of the City's grants on immigration legal services to community-based organizations. As shown in Exhibit 1 below, in FY 2025-26 and FY 2026-27, MOHCD's budget for immigration legal services is \$12,339,016 for each fiscal year, which funds a total of 12 agencies across various program areas. This funding level was a decrease from the \$13,140,826 budgeted in FY 2024-25.

As shown above, the largest program receiving funding is the Immigrant Legal Defense Collaborative, a consortium of sixteen legal organizations providing services to immigrants facing removal proceedings. MOHCD also directly funds non-profits that provide routine legal services for immigrants and a rapid response program for the immediate legal needs of immigrants.

DETAILS OF PROPOSED LEGISLATION

The proposed ordinance would appropriate \$3.5 million from the General Reserve to the Mayor's Office of Housing and Community Development (MOHCD) to fund the following in FY 2025-26:

(1) \$1.86 million to community-based organizations for immigration legal defense, and (2) \$1.64 million to community-based organizations for response services.

According to MOHCD, specific community-based organizations and programs to be funded have not yet been identified, as the Department will determine the appropriate procurement approach following approval of the proposed ordinance by the Board of Supervisors. These determinations will inform the timeline for fund disbursement. In addition, the specific number of staff positions to be potentially funded will be determined during the grant negotiation process.

Exhibit 2 below shows MOHCD's overview of anticipated services to be funded by the proposed appropriation.

MOHCD states that proposed services were identified based on the Department's institutional knowledge of the landscape of immigration legal defense and response services and community needs. In addition, the Department conducted a review of procurement proposals, funded

activities, outcomes and grant reports in 2024 of the immigration legal services grant portfolio to identify effective strategies and inform future funding opportunities.

FISCAL IMPACT

The ordinance would appropriate \$3.5 million from the General Reserve to the MOHCD, as shown in Exhibit 3 below.

The appropriation is for MOHCD's community-based services account, which the Department plans to allocate to legal defense and response services. As shown above, of the \$3.5 million proposed appropriation, \$1.86 million (53.1 percent) will fund community-based organizations providing immigration legal defense, and \$1.64 million (46.9 percent) will fund community-based organizations providing response services.

General Reserve

The General Reserve balance for the current fiscal year is approximately \$164.3 million. The proposed \$3.5 million appropriation from the General Reserve would reduce that balance accordingly, and any amount used from the General Reserve in the current fiscal year must be replenished in the following fiscal year pursuant to the City's reserve policies. The General Reserve balance is required to be 2.5 percent of budgeted regular General Fund revenues in FY 2025-26 and 2.75 percent in FY 2026-27.

POLICY CONSIDERATION

As previously mentioned, MOHCD has not finalized how the proposed funding will be distributed. Consequently, we recommend the Mayor's Office consider the following factors when determining funding allocations to service providers:

- **Barriers to Access:** Are any linguistic, cultural, transportation or any other barriers impacting service reach? If so, would the proposed funding address those service gaps?

- **Vulnerable Marginalized Communities:** Are any marginalized communities and/or subcommunities (such as DACA recipients², unaccompanied minors, Indigenous migrants, and family members of deported individuals facing financial instability) disproportionately impacted by the recent uptick in immigration enforcement? If so, how will the proposed funding address that?
- **Performance of Providers:** Are providers meeting performance expectations? This may include service/outcome objectives such as the number of completed cases, outcomes of immigration cases, client satisfaction, number of clients served, number and percentage of clients referred to and assigned a lawyer, and deportation prevention outcomes.
- **Capacity of Providers:** Can those receiving additional funding staff up quickly?
- **Cost Effectiveness:** How do the costs of services compare among providers? Are there opportunities to fund lower cost services within the existing provider portfolio?

RECOMMENDATION

Approval of the proposed ordinance is a policy matter.

Dear Board of Supervisors,

My name is Crystal Van and I am the Senior Program Manager for the Civic Engagement team at Chinese for Affirmative Action (CAA). This year, I have also been trained to be a dispatcher with the San Francisco Rapid Response Network hotline due to the influx of calls seeking consultation for immigration resources and legal services.

Immigrant service providers and community members across the Bay Area are facing an unprecedented threat from the current federal administration. Lawyers and legal practitioners are witnessing the unlawful arrest and detention of Bay Area residents right here in San Francisco. People who are following the legal process to live in this country are being taken into custody and deported after simply showing up for check-ins or court hearings.

I've heard from multiple residents throughout the Bay Area and across California who are terrified after receiving letters ordering them to appear in San Francisco. They've heard that others in the same situation have been detained and deported, and are seeking urgent guidance and assistance. These are targeted, strategic actions designed to mass deport our neighbors and families. Many are being removed without access to proper legal consultation or even knowing their basic constitutional rights.

Thankfully, because of decades of work by trusted immigrant rights organizations like SFILN, SFILDC, and RRN, we have strong networks in place to provide emergency support. But with immigration-related detentions increasing by 900% (from 300 per day in 2024 to 3,000 per day in 2025 nationally) our networks are stretched to the limit. There's simply not enough staff and resources to provide comprehensive legal response, accompaniment, and emergency support with the current demand.

Last night at the IRC hearing, we heard from the Public Defender's Office that people are even being detained at 630 Sansome Street for more than 24 hours, and sometimes up to 72 hours. These holding cells are not meant for long-term detention and are unsafe for our residents. We need more support to combat these unjust tactics.

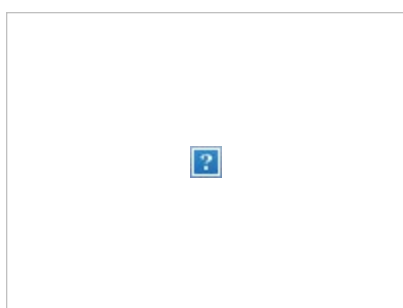
Therefore, I'm calling on the Board of Supervisors to invest in immigrant legal services and resources here in San Francisco by allocating \$3.5 million funds to SFILN, SFILDC, and

RRN in response to these reprehensible federal directives. We need more lawyers, more capacity, and stronger infrastructure to defend our communities. When the federal government violates constitutional rights, local and state governments must step up and protect our residents.

I urge you to stand firm in our commitment as a Sanctuary City, a home to vibrant, diverse immigrant communities, and to continue the fight against authoritarianism. Please fund our communities, fund our legal networks, and citywide immigrant rights collaborative.

Thank you President Mandelman, Budget Chair Chan, Supervisor Fielder, and other Supervisors for already spearheading these efforts!

Good afternoon, Supervisors,

My name is Annette Wong with Chinese for Affirmative Action, a founding member of the San Francisco Immigrant Legal and Education Network and partner on the San Francisco Rapid Response Network.

First, I want to acknowledge the moment. I think we're all breathing a sigh of relief that we are not a militarized war zone today. We want to thank the City and all the CBO partners in the house today for moving quickly and standing firm in response to last week's threats of federal troop deployment in San Francisco. The public statements, coordination, and outreach helped reassure immigrant communities that our city continues to stand with immigrants—especially in moments of fear and uncertainty.

But as we all know, this moment isn't over. The threat of heightened immigration enforcement in San Francisco and across the Bay Area remains real. San Francisco's leadership has always shown the country what a true sanctuary city looks like—not just in name, but in action. This investment will help us continue that legacy: protecting families, safeguarding workers, and keeping our communities strong and united

in the face of federal overreach.

This supplemental reaffirms that in San Francisco, we don't turn our backs on immigrants—we stand together and we fight back.

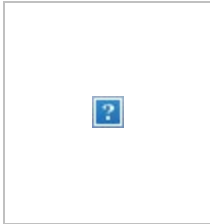

My name is Elizabeth (Eli) Rico Mosby, and I am writing to express my strong support for the \$3.5 million supplemental funding request for immigration services. This funding will allow immigrant-serving organizations to continue providing critical legal representation, community education, and emergency response; services that keep families together and uphold San Francisco's long-standing sanctuary commitment.

I have worked in immigration law in San Francisco for over seven years, supporting immigrant families who continue to fight for the same safety and dignity that so many of our own families once hoped for. Through my work with La Raza Community Resource Center as a DOJ Accredited Representative and Legal Coordinator, and now with Mission Action as a Defensive Immigration Intern, I have seen firsthand how this work is made possible through the City's investment in SFILEN, SFILDC, and the San Francisco Rapid Response Network. These programs make it possible for allies and advocates like myself and many others to continue helping families access protection, legal representation, and hope.

The organizations that make up SFILEN, Rapid Response, and SFILDC provide direct legal representation and critical support to hundreds of immigrants and their families each year. Together, they handle cases involving asylum, deportation defense, family petitions, U visas for survivors of violence, and work authorization applications, amongst others. They are the backbone of San Francisco's safety net for immigrant families, ensuring that when someone is detained there is an attorney ready to respond, when a family receives a Notice to Appear there is someone who can explain their rights, and when a child faces separation from their beloved parents there is a team working to keep them safe and together.

However, resources are stretched to the limit. Caseloads have grown while funding has not kept pace with the urgent need. Limited funding restricts the ability of our

organizations to maintain stable staffing and infrastructure at a time when the demand for immigration representation continues to grow with each new set of procedural and policy changes issued by the Department of Homeland Security and United States Citizenship and Immigration Services. These changes are occurring with unprecedented speed, creating new requirements, deadlines, and filing obligations that make each case more complex and time-intensive. Without adequate funding, our legal teams struggle to maintain the level of responsiveness and preparation that these developments require, weakening the city's coordinated response and leaving many families without the representation they urgently need.

The proposed \$3.5 million in supplemental funding will make a tangible difference by strengthening organizational capacity through competitive and equitable staff compensation, retention of experienced attorneys and paralegals, and the addition of essential administrative support to improve coordination and compliance. It will also help ensure that legal and education partners can continue providing consistent outreach, community workshops, and high-quality representation that hundreds of San Franciscans rely on each year. This investment will safeguard and bolster the city's immigrant legal infrastructure and ensure its long-term stability and effectiveness.

This support not only provides safety and stability for immigrant families but also gives them the freedom to live without fear, to step out of the shadows, and to fully contribute to the social, commercial, and economic success of San Francisco. Our city thrives when immigrants are able to work openly, build businesses, and participate in civic life. When we invest in immigrant protection, we invest in the strength and prosperity of San Francisco itself.

I want to thank all the Board of Supervisors members for continuing to stand with our immigrant community and for defending the values that make this city a true sanctuary. Supporting this funding means supporting the families, workers, and students who make San Francisco thrive. My name is Brandon Vesely, and I am an immigration attorney with Mission Action, a non-profit organization located in District 9.

I write to express my strong support for the supplemental budget request for immigration legal services co-sponsored by Supervisors Chan, Chen, Walton, Fielder, and Mahmood. City funding enables Mission Action, alongside a robust network of non-profit organizations, to provide a wide range of services to San Francisco's immigrant community, including but not limited to, full-scope representation for residents at risk of deportation and emergency legal interventions for San Francisco residents that are arrested by ICE. Several weeks ago, a colleague and I raced to ICE's offices on 630 Sansome Street after ICE kidnapped one of our neighbors at a routine immigration court hearing, despite his pending application for asylum. As part of our network's response, a partner organization filed a habeas petition and secured his release the same day.

Nonetheless, existing funding levels are not adequate to sustain the level of services that this moment requires. The dedicated team of legal advocates that I work with are increasingly struggling to meet the overwhelming need for immigration legal services and interventions amidst the Trump administration's escalating attacks on immigrants. The stakes have never been higher for our immigrant neighbors. Just last week, the administration threatened to unleash masked ICE officers, supported by the national guard, on the streets of San Francisco harass and detain immigrant community members. Please meet the urgency of this moment and stand up for San Francisco's most vulnerable residents by approving this important supplemental budget request.
