8 WHEREAS, the City and County of San Francisco relies heavily on trained volunteers
9 in times of crisis; and,

10 WHEREAS, The 2002 Supplemental Appropriations Act for Further Recovery From
11 and Response to Terrorist Attacks on the United States (Public Law 107-206) authorizes
12 federal funding to State and local governments to support Citizens Corps activities and
13 Community Emergency Response Teams, known in the City and County of San Francisco as
14 Neighborhood Emergency Response Teams; and,

15 WHEREAS, The California Governor's Office on Service and Volunteerism has been
16 delegated responsibility for the administration of these funds within California and grant funds
17 are available from the Governor's Office of Emergency Services for Citizens Corps activities
18 and Community Emergency Response Team programs; and,

19 WHEREAS, The grant budget includes provision for indirect costs of \$1,247; now,
20 therefore, be it


21 RESOLVED, That the Board of Supervisors hereby authorizes the Director of the




