

1 [Liquor License Modification, 1371 Grant Avenue]

2 RESOLUTION DETERMINING THAT THE MODIFICATION OF THE CONDITION  
3 IMPOSED ON THE CONDITIONAL ALCOHOLIC BEVERAGE LICENSE FOR STEFAN  
4 WEVER AND ROBERT WALKER FOR B.S.B. PROPERTIES, INC. DBA "GRANT AND  
5 GREEN SALOON" (ALSO KNOWN AS THE GRANT AND GREEN BLUES CLUB)  
6 LOCATED AT 1371 GRANT AVENUE, TO ALLOW THE HOURS OF OPERATION  
7 FROM 10 A.M. TO 2 A.M. SEVEN DAYS A WEEK INSTEAD OF THE HOURS  
8 RESTRICTED BY THE CURRENT CONDITION NO. 1 ON A TYPE 48 LIQUOR  
9 LICENSE THAT MR. WEVER AND MR. WALKER ARE IN THE PROCESS OF  
10 PURCHASING FROM THOMAS STANFORD WEHR, IS JUSTIFIED UNDER THE  
11 PROVISIONS OF SECTION 23803 OF THE CALIFORNIA BUSINESS AND  
12 PROFESSIONS CODE; WITH A CONDITION.

14 WHEREAS, Stefan Wever and Robert Walker who are in the process of  
15 purchasing a license from Thomas Stanford Wehr for B.S.B. Properties, Inc. dba "Grant  
16 and Green Saloon" (also known as the Grant and Green Blues Club) located at 1371  
17 Grant Avenue, are seeking the removal of Condition 1; and,

18 WHEREAS, The City Planning Department has verified that the area is properly  
19 zoned; and

20 WHEREAS, The Police Department recommends the approval of the removal of  
21 Condition 1 on this Type 48 liquor license; however with the addition of a new condition;  
22 now, therefore, be it

23 RESOLVED, That in accordance with Section 23803 of the California Business  
24 and Professions Code, the Board of Supervisors of the City and County of San  
25 Francisco hereby determines to approve the request of Stefan Wever and Robert

1 Walker to modify the Type 48 liquor license that they are in the process of purchasing  
2 from Thomas Stanford Wehr, to remove Condition 1.

3 Condition: The removal or modification of conditions to this license applies only  
4 to the above-mentioned applicants (Transferee). If this sale or transfer fails, the original  
5 conditions should remain.


