

1 [Approval of the Ryan White HIV/AIDS Treatment Modernization Act grant application.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to submit**
4 **an application for the San Francisco Eligible Metropolitan Area (EMA) by the deadline**
5 **of September 29, 2008, requesting a total amount of \$36,118,233, to the Health**
6 **Resources Services Administration (HRSA) to continue to receive funding for the Ryan**
7 **White HIV/AIDS Treatment Modernization Act Grant (Ryan White Programs, Part A); for**
8 **the next grant year, March 1, 2009 through February 28, 2010.**

10 WHEREAS, Section 10.170.(b) of the San Francisco Administrative Code requires
11 Board review of proposed annual or otherwise recurring grant applications of \$5,000,000 or
12 more prior to their submission; and,

13 WHEREAS, DPH currently receives this annual, recurring grant, known as Ryan White
14 Programs, Part A from HRSA for the funding period of March 1, 2008 through February 28,
15 2009 in the amount of \$23,536,385, of which \$4,758,228 was a one-time grant, for the San
16 Francisco Eligible Metropolitan Area (EMA), including the City and County of San Francisco
17 (CCSF), Marin and San Mateo Counties, with \$20,728,396 allocated for CCSF; and,

18 WHEREAS, The SF EM A is applying for \$36,118,233 in funding for the FY 2009-10
19 funding period, and anticipates receiving approximately \$18,778,157, with \$16,567,807
20 allocated for CCSF; and,

21 WHEREAS, These funds cover a multitude of health services to HIV positive persons
22 residing in the three counties within the San Francisco EMA; and,

23 WHEREAS, DPH was unable to submit a resolution to the Board of Supervisors for
24 approval 60 days in advance of the application due date, as required, because DPH received

1 the application guidance from HRSA on July 29, 2007 and is actively working on the
2 application which is due on September 29, 2008; and,

3 WHEREAS, in the interest of timeliness, DPH is making this request for approval by
4 submitting last year's application for the Ryan White Programs, Part A grant, including
5 supporting documents as required, all of which is on file with the Clerk of the Board of
6 Supervisors in File No. 081111, which is hereby declared to be part of the
7 Resolution as if set forth fully herein; and, now, therefore, be it

8 RESOLVED, That the Board of Supervisors hereby approves DPH's application for the
9 Ryan White Programs, Part A grant for the funding period of March 1, 2009 through February
10 28, 2010 for \$36,118,223, to be submitted no later than September 29, 2008.


