4 **pursuant to Board of Supervisors Rules of Order, Sections 4.2 and 4.2.1, by cancelling**
5 **the Regular Board meetings of January 20, February 17, May 26, September 8, October**
6 **13 and December 1; and all Regular Board and Committee meetings during the spring,**
7 **summer, and winter breaks beginning March 30 through April 3, 2026 (returning on**
8 **April 6, 2026), beginning August 3 through August 28, 2026 (returning on August 31,**
9 **2026), and beginning December 16, 2026, through January 7, 2027 (returning on**
10 **January 8, 2027); and further suspending portions of Board Rule 4.2. to effectuate**
11 **certain dates within the regular meeting schedule to augment the flow of business.**

13 WHEREAS, The Board of Supervisors Rules of Order, Section 4.2, states the Board
14 shall hold a regular meeting in the Legislative Chamber in City Hall each Tuesday at
15 2:00 p.m., unless it is a holiday or the day following a holiday, in which case the meeting shall
16 be cancelled; and

17 WHEREAS, The Rules of Order Section 4.2.1 also states that during holiday periods,
18 the application of specific days of the week described in the rules shall be revised by the Clerk
19 of the Board as necessary for the efficient conduct of the legislative process or to facilitate the
20 transition of District offices; and

21 WHEREAS, The Rules of Order Section 4.2 further states “the Board shall not meet
22 during the week after Thanksgiving, or between December 24 and December 31”; and

23 WHEREAS, Similar to other sitting legislative bodies in the United States, the Board
24 has established recess periods during the spring, summer, and winter which Members of the
25 Board may plan to be away, without missing any Board or Committee meetings or other

1 important public business, and without causing difficulties in achieving a quorum; now,
2 therefore, be it

3 MOVED, Pursuant to Board Rules 4.2 and 4.2.1, the following Board meetings are
4 cancelled: January 20 (Martin Luther King Jr. Day); February 17 (President's Day); May 26
5 (Memorial Day); September 8 (Labor Day); October 13 (Italian American Heritage Day and
6 Indigenous Peoples Day); and December 1, 2026 (Thanksgiving); and, be it

7 FURTHER MOVED, That pursuant to the established tradition of spring, summer, and
8 winter recess periods, the Regular Board and Committee meetings scheduled beginning
9 March 30 through April 3, 2026 (returning on April 6, 2026), beginning August 3 through
10 August 28, 2026 (returning on August 31, 2026), and beginning December 16, 2026, through
11 January 7, 2027 (returning on January 7, 2027), are hereby cancelled; and, be it

12 FURTHER MOVED, Pursuant to Board Rule 4.3 the Board is constrained by certain
13 administrative, electoral and legislative deadlines and may schedule Special Meetings when
14 necessary to conduct the City's business.

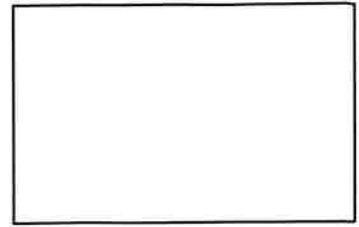
