Resolution honoring the outstanding service of Ahsha Safaí, Supervisor for San

Francisco's District 11, and declaring December 17, 2024, as Supervisor Ahsha Safaí

Day in the City and County of San Francisco.

WHEREAS, Supervisor Ahsha Safaí has demonstrated over 30 years of public service, beginning his career working for the honorable Mayor Willie Brown to protect immigrants from losing their housing and advancing key gang violence prevention strategies; and

WHEREAS, Supervisor Safaí then worked for the honorable Mayor Gavin Newsom connecting young adults, formerly incarcerated, and homeless people to good paying jobs to help clean the streets and beautify public spaces; and

WHEREAS, Supervisor Safaí spent nearly a decade as a labor organizer, representing frontline workers like janitors, sanitation workers, delivery drivers, and grocery store employees, helping to raise the San Francisco minimum wage to \$15/hour; and

WHEREAS, Supervisor Safaí once elected Supervisor of District 11 in 2016 passed legislation to streamline housing construction, helped secure funding for and support the construction of over 600 new housing units in the district with 64% affordable for working families and 40% set aside for District 11 neighbors, passed a retail workers bill of rights, secured a citywide project labor agreement to increase wages for workers, and led the effort to pass Proposition C in 2022, creating a citizen oversight board over the Department of Homelessness and Supportive Housing; and

WHEREAS, Supervisor Safaí has been an unapologetic champion for the immigrant community, working closely with many advocacy groups and grassroots community

1	organizations such as Faith in Action, to amplify the voices of communities who are most
2	impacted by public policy; and
3	WHEREAS, Supervisor Safaí helped small businesses facing challenges starting and
4	doing business in San Francisco, passed legislation focused on community policing to bring
5	more foot patrols to our neighborhoods and to allow Deputy Sheriffs to patrol commercial
6	corridors, all while planting approximately 3,000 trees in his eight years in office and securing
7	\$1.4M in public safety traffic calming measures in over 150 locations; now, therefore, be it

9	Ahsha Safaí for his unwavering commitment to San Francisco, its residents and workers; and,
