6 **and County of San Francisco, et al.); the lawsuit involves alleged personal injury on a**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Kristen Lewett v. City and County of
12 San Francisco, et al.), San Francisco Superior Court, Case No. CGC-19-580048 by the
13 payment of \$500,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 October 18, 2019, and the following parties were named in the lawsuit: plaintiff: Kristen
16 Lewett; defendants: City and County of San Francisco, Mathew Hom, Susan K. Hom,
17 Jeanette L. Woo, Lawrence M. Costello and George Costello, As Co-Trustees Of The Costello
