3 **Resolution approving the third amendment for Contract No. 1000014147 for the**
4 **Japanese Community Youth Council - Opportunities for All Intermediary Program**
5 **between the Japanese Community Youth Council and the City and County of San**
6 **Francisco, acting by and through its Department of Children, Youth and Their Families,**
7 **to increase the grant agreement amount by \$2,208,458 for a total not to exceed amount**
8 **of \$10,326,458 with no change to the length of term from July 1, 2019, through June 30,**
9 **2024.**

11 WHEREAS, The Japanese Community Youth Council – Opportunities for All
12 Intermediary Program provides youth with access to work-readiness training, work-based
13 learning, and employment opportunities; and

14 WHEREAS, Opportunities for All Intermediary Program serves more than 2,018 San
15 Francisco youth annually; and

16 WHEREAS, The Opportunities for All Intermediary Program fulfills the Youth Workforce
17 Development Strategy of the Department of Children, Youth and Their Families' Youth
18 Workforce Development Service Area, as described in the department's Request for
19 Proposals issued August 18, 2017; and

20 WHEREAS, The Department of Children, Youth and Their Families entered into a grant
21 agreement with the Japanese Community Youth Council effective July 1, 2019, to June 30,
22 2023, with a not to exceed amount of \$1,958,000; and

23 WHEREAS, The Department of Children, Youth and Their Families amended the
24 original grant agreement on October 8, 2019, to increase the grant amount by \$1,870,000 for
25 a revised not to exceed amount of \$3,828,000; and

1 WHEREAS, The City and County of San Francisco entered into a second amendment
2 to the grant agreement with the Japanese Community Youth Council, effective on and after
3 January 9, 2020, to increase the grant amount by \$4,290,000 for a revised not to exceed
4 amount of \$8,118,000 and to extend the grant term to June 30, 2024; and

5 WHEREAS, The City and County of San Francisco wishes to enter into a third
6 amendment to the grant agreement with the Japanese Community Youth Council to increase
7 the grant amount by \$2,208,458 for a revised not to exceed amount of \$10,326,458; now,
8 therefore, be it

9 RESOLVED, That the Board of Supervisors hereby authorizes a third amendment to
10 the grant agreement between the City and County of San Francisco and the Japanese
11 Community Youth Council to support the Opportunities for All Intermediary program during the
12 period of July 1, 2019, to June 30, 2024, for a total not to exceed amount of \$10,326,458; and,
13 be it

14 FURTHER RESOLVED, That within thirty (30) days of the modification being fully
15 executed by all parties, the Department of Children, Youth and Their Families shall provide
16 the final grant agreement to the Clerk of the Board for inclusion into the official file.
