APPROVING THE CHILDREN'S SERVICES PLAN FOR THE SAN FRANCISCO CHILDREN'S FUND IN ACCORDANCE WITH CHARTER SECTION 16.108

WHEREAS, In November 1991 the voters of San Francisco enacted a charter amendment which established the San Francisco Children's Fund; and

WHEREAS, The provision of this section requires that the City revenues set aside for the fund be used exclusively to provide services to children, less than 18 years of age, above and beyond services funded prior to the adoption of the amendment; and

WHEREAS, This section further requires the Health Commission, Juvenile Probation Commission, Human Services Commission, Public Library Commission and Recreation and Parks Commission to hold public hearings on the Plan and those hearings were or will be held March 2, 1999, February 24, 1999, February 25, 1999, March 2, 1999; and February 18, 1999, respectively; and

WHEREAS, the Board of Supervisors provides important oversight for the Children's Services Fund, and is acutely aware that accountability to the public is of critical importance in a fund that was created by the voters; and

WHEREAS, In accordance with Charter Section 16.108, the Mayor has submitted a Children's Services Plan that proposes goals and objectives for the Fund, and designates City Departments for the administration of the Fund for the fiscal year beginning July 1, 1999; now therefore, be it

RESOLVED, That the Board of Supervisors approve the 1999-2000 Children's Services Plan submitted by the Mayor in accordance with Charter Section 16.108. a copy of which is on file at the Board of Supervisors; and, be it

FURTHER RESOLVED, That on or about July 15, 1999, the Department of Children, Youth and Their Families submit a detailed budget supporting the \$700,000 allocation for evaluation services, including the identification of all outside consultants and nonprofit agencies, the amount allocated to each specific organization, the estimated hours of service to be provided, and the average hourly rates to be charged by each organization.
