

1 [Affirming Pacific Islander Communities in San Francisco]

3 **Resolution affirming the City and County of San Francisco's commitment to the safety,**  
4 **dignity, and belonging of Pacific Islander communities, and condemning hate,**  
5 **violence, and efforts to erase Pacific Islander cultural presence in San Francisco.**

7 WHEREAS, Pacific Islanders have a deep and enduring history in San Francisco,  
8 rooted in resilience, cultural contribution, labor, family, and community building; and

9 WHEREAS, Pacific Islander communities in San Francisco have long been  
10 underrepresented and disproportionately affected by social, economic, and public health  
11 disparities; and

12 WHEREAS, Pacific Islander communities in San Francisco have faced a rising tide of  
13 hate, violence, and targeted threats that seek to diminish their presence, question their  
14 significance, and challenge the legitimacy of their cultural institutions and community spaces;  
15 and

16 WHEREAS, These threats and acts of harm are not isolated incidents but represent a  
17 broader pattern of targeted discrimination against Pacific Islander people and their entire  
18 community; and

19 WHEREAS, False narratives have been spread about Pacific Islander communities  
20 with the intent to undermine their place in this City and erode the recognition and investment  
21 they have earned; and

22 WHEREAS, Pacific Islander residents, organizations, and community leaders have  
23 responded with resilience, solidarity, and a clear declaration that they will not be erased or  
24 displaced; and

1           WHEREAS, SALT Pacific Islander Association, the first Pacific Islander-led coalition of  
2 various Pacific Islander voices in San Francisco, has been a steward of Pacific Islander  
3 cultural life in this City and an author and co-author of five historical policies, initiatives, and  
4 resolutions; and

5           WHEREAS, Cultural districts, community institutions, and visible civic presence are  
6 necessary tools for preserving culture, supporting community wellness, and ensuring that  
7 future generations of Pacific Islanders can thrive in San Francisco; and

8           WHEREAS, On April 7, 2026, Pacific Islander community members gathered at City  
9 Hall to declare that Pacific Islanders belong here, have always been part of this City, and  
10 deserve recognition, protection, and investment; and

11           WHEREAS, The Board of Supervisors stands in solidarity with all communities facing  
12 discrimination, hate, and injustice, and affirms that every community in San Francisco has the  
13 right to exist, to be seen, and to thrive free from hate; now, therefore, be it

14           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
15 hereby condemns all acts of hate, violence, and targeted discrimination against Pacific  
16 Islander communities; and

17           FURTHER RESOLVED, That the Board of Supervisors affirms the right of Pacific  
18 Islander communities to cultural recognition, institutional support, and full and visible  
19 participation in the civic life of San Francisco; and

20           FURTHER RESOLVED, That the Board of Supervisors calls on all City institutions to  
21 ensure accountability, protection from harm, and meaningful inclusion of Pacific Islander  
22 voices in the decisions that shape their neighborhoods and their City; and

23           FURTHER RESOLVED, That San Francisco reaffirms its commitment to being a City  
24 where every community, including Pacific Islander residents, belongs, is protected, and can  
25 thrive for generations to come.
