3	Motion appointing Kelly Kotson, Mona Malan (residency requirement waived), and
4	Claudia Quinonez, terms ending September 14, 2020, to the Child Care Planning and
5	Advisory Council.

7	MOVED, That the Board of Supervisors of the City and County of San Francisco does
8	hereby appoint the hereinafter designated persons to serve as members of the Child Care
9	Planning and Advisory Council, pursuant to the provisions of the Administrative Code, Article
10	XX, Section 5.200, and Section 10.100-367, and California Education Code, Sections 8499.3-
11	8499.7, for the terms specified:
12	Kelly Dotson, seat 1, succeeding themself, term expired, must be a nominee of the
13	District 1 Supervisor and represent one of the following categories: consumers, child care
14	providers, discretionary, community representatives, or public agency representatives, for the
15	unexpired portion of a three-year term ending September 14, 2020.
16	Mona Malan (residency requirement waived), seat 7, succeeding Sandee Blechman,
17	term expired, must be a nominee of the District 7 Supervisor and represent one of the
18	following categories: consumers, child care providers, discretionary, community
19	representatives, or public agency representatives, for the unexpired portion of a three-year
20	term ending September 14, 2020.
21	Claudia Quinonez, seat 11, succeeding themself, term expired, must be a nominee of
22	the District 11 Supervisor and represent one of the following categories: consumers, child
23	care providers, discretionary, community representatives, or public agency representatives,
24	for the unexpired portion of a three-year term ending September 14, 2020.

1 FURTHER MOVED, That the Board of Supervisors makes the following findings: 1. The membership of the Child Care Planning and Advisory Council has a goal to be 2 3 representative of the diversity of the City and County of San Francisco. 2. Applicant Mona Malan, who is not a resident of San Francisco, is a person with 4 5 experience that uniquely qualifies them to serve on the Child Care Planning and 6 Advisory Council. 3. The Child Care Planning and Advisory Council has attempted to fill the position, for 7 8 which Mona Malan was nominated, with an individual who is a City resident and 9 who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Mona Malan is qualified 10 to serve on the Child Care Planning and Advisory Council. 11 4. After exercising due diligence, the Board of Supervisors concludes that there is no 12 13 other possible representative, who is a resident of San Francisco, and who has the specific experience, skills, or qualifications possessed by this applicant, and who is 14 15 willing to serve on the Child Care Planning and Advisory Council at this time; and, 16 be it 17 FURTHER MOVED, That the Board of Supervisors waives the residency requirement 18 for Mona Malan, as allowed in cases where no qualified City resident(s), willing to serve, can 19 be found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to 20 boards, commissions, and advisory bodies established by legislative act of the Board of 21 Supervisors to be resident(s) of the City and County of San Francisco. 22
