16 character that makes San Francisco great; and

17 WHEREAS, Despite being the hardest hit community by the health, economic, and  
18 educational disparities exacerbated by the unprecedented pandemic, the Latinx community  
19 has proven to be essential to the resiliency, economic recovery and prosperity of this City,  
20 State, and Country; and

21 WHEREAS, The Latinx community is a significant part of the fabric of our society and  
22 continues to make valuable contributions to the culture, economy, and thriving livelihood of  
23 the City and County of San Francisco; now, therefore, be it
