[Charter Amendment - Children and Youth Fund; Commission on Children, Youth, and Their Families]

Describing and setting forth a proposal to the voters to amend the Charter of the City and County of San Francisco to : 1) renew and rename the Children’s Fund and eliminate the Fund’s expiration date; 2) increase the property tax set-aside for the Fund from three cents per \$100 of assessed valuation to five cents; 3) provide for services for at-risk youth 18 to 24 years old; 4) revise and expand the planning process for expenditures from the Fund; 5) modify the advisory committee for the Fund; 6) create a Commission on Children, Youth and Their Families; and 7) repeal an obsolete section of the Charter, at an election to be held on November 4, 2014.

Section 1. The Board of Supervisors hereby submits to the qualified voters of the City and County, at an election to be held on November 4, 2014, a proposal to amend the Charter of the City and County by amending Section 16.108, adding a new Section 4.133, and repealing former Section 4.133, to read as follows:

SEC. 16.108. CHILDREN AND YOUTH FUND ~~CHILDREN'S FUND~~.

(a) **Fund for Children and Youth ~~Children's~~ Services.** Operative July 1, 2001, there is hereby established a fund to expand children's services, which shall be called the Children and Youth Fund ~~Children's Fund~~ ("Fund"). Monies in the Fund shall be expended or used only to provide services for children and youth as provided in this section.

(b) **Goals.** ~~The goals of expenditures from the Fund shall be:~~ The goals of expenditures

1 from the Fund and the planning process created in this section of the Charter shall be:

2 1. To ensure that San Francisco's children are healthy, ready to learn, succeed
3 in school and live in stable, safe and supported families and communities;

4 2. To ensure that San Francisco is a family-friendly city and to support families
5 as an important part of the city population and civic culture;

6 3. To focus on the prevention of problems and on supporting and enhancing the
7 strengths of children, youth and their families;

8 4. To complement the City's community development efforts;

9 5. To strengthen a community-based network of services in all neighborhoods;

10 6. To ensure that children and youth with the highest needs receive maximum
11 benefit from the Fund and that equity is a guiding principle of the funding process;

12 7. To distribute funds based on best practices and successful and innovative
13 models in order to ensure maximum impact;

14 8. To the maximum extent feasible, distribute funds equitably among services for
15 all age groups – from infancy to transitional-aged youth;

16 9. To ensure children are provided with gender-responsive and culturally-
17 competent services;

18 10. To strengthen collaboration around shared outcomes among all service
19 providers for children, youth and their families, including collaboration among public agencies
20 and non-profit organizations; and,

21 11. To fill gaps in services and leverage other resources whenever feasible.

10 (c) **Amount.** There is hereby set aside for the Fund, from the revenues of the property
11 tax levy, revenues in an amount equivalent to an annual tax of three cents (\$.03) per one hundred
12 dollars (\$100) of assessed valuation for each fiscal year beginning with July 1, 2001-June 30,
13 2002, ~~and ending with July 1, 2015-June 30, 2016.~~ Beginning July 1, 2015, there is hereby set
14 aside for the Fund, from the revenues of the property tax levy, revenues in an amount equivalent
15 to an annual tax of five cents (\$.05) per one hundred dollars (\$100) of assessed valuation for
16 each fiscal year. ~~If the 2010 U. S. Census shows that children make up a percentage of the~~
17 ~~population of the City and County that is at least two percentage points more than their~~
18 ~~percentage as shown in the 2000 U. S. Census, then the amount of the property tax levy set aside~~
19 ~~under this section shall be increased for each fiscal year beginning after publication of the 2010~~
20 ~~Census. The increase shall be in an amount equal to: one quarter cent (\$.0025) per one hundred~~
21 ~~dollars of assessed valuation, for each two full percentage points of increase in the percentage of~~
22 ~~the City and County population that is made up of children.~~ The Fund shall be maintained
23 separate and apart from all other City and County funds and appropriated by annual or
24 supplemental appropriation.
25

1 (d) **New Services.** Monies in the Fund shall be used exclusively for the costs of services
2 to children less than 18 years old provided as part of programs that predominantly serve children
3 less than 18 years old and for Disconnected Transitional-Aged Youth 18 to 24 years old.
4 “Disconnected Transitional-Aged Youth” are those who: are homeless or in danger of
5 homelessness; have dropped out of high school; have a disability or other special needs,
6 including substance abuse; are young, unmarried parents; are undocumented; are immigrants
7 and/or English Learners; are Lesbian, Gay, Bisexual, Transgender, Queer, and Questioning
8 (“LGBTQQ”); and/or are transitioning from the foster care, juvenile justice, criminal justice or
9 special education systems. Monies in the Fund shall be used exclusively for the costs of services
10 above and beyond services funded from sources other than the previous Children's Fund prior to
11 July 1, 2001. To this end, monies from the Fund shall not be appropriated or expended for
12 services that received any of the funds included in the higher of the Controller's baseline budget
13 covering July 1, 2000-June 30, 2001 appropriations, or the Controller's baseline budget covering
14 July 1, 1999-June 30, 2000 appropriations, whether or not the cost of such services increases.
15 Nor shall monies from the Fund be appropriated or expended for services that substitute for or
16 replace services included or partially included in the higher of the two baseline budgets, except
17 and solely to the extent that the City ceases to receive federal, state or private agency funds that
18 the funding agency required to be spent only on those services. The Controller's baseline budget
19 shall mean the Controller's calculation of the actual amount of City appropriations for services
20 for children that would have been eligible to be paid from the Fund but are paid from other
21 sources.

22 (e) **Eligible Uses Services.** The City may only use monies from the Fund for the
23 following purposes: Services for children eligible for Fund assistance shall include only:

24 (1) Services for children up to 18 years old and Disconnected Transitional-Aged
25 Youth up to 24 years old, including:

1 (A) ~~(1)~~ Affordable child care and early education;
2 (B) ~~(2)~~ Recreation, cultural and after-school programs, including without
3 limitation, arts programs;
4 (C) ~~(3)~~ Health services, including prevention, education, mental health,
5 and pre-natal services to pregnant women;
6 (D) ~~(4)~~ Training, employment and job placement;
7 (E) ~~(5)~~ Youth empowerment and leadership development;
8 (F) ~~(6)~~ Youth violence prevention programs;
9 (G) ~~(7)~~ Youth tutoring and educational enrichment programs; ~~and~~
10 (H) ~~(8)~~ Family and parent support services for families of children
11 receiving other services from the Fund; ~~and-~~

12 (I) Services responsive to issues of gender, sexual orientation, and gender
13 identification, including, but not limited to, services to address the needs of girls and LGBTQ
14 communities.

15 (2) Funding for the Department of Children, Youth and Their Families
16 ("DCYF") and the Commission on Children, Youth and Their Families ("Commission").

17 (3) Administration of the Fund and evaluation of Fund goals and services.

18 (4) Technical assistance and capacity-building for service providers and
19 community-based partners.

20 (f) **Excluded Services.**

21 (1) Notwithstanding subsection (e), services for children paid for by the Fund
22 shall not include:

23 (A) ~~(1)~~ Services provided by the Police Department or other law
24 enforcement agencies, courts, the District Attorney, Public Defender, City Attorney; or the Fire
25

1 Department; detention or probation services mandated by state or federal law; or public
2 transportation;

3 (B) ~~(2)~~ Any service that benefits children incidentally or as members of a
4 larger population including adults;

5 (C) ~~(3)~~ Any service for which a fixed or minimum level of expenditure is
6 mandated by state or federal law, to the extent of the fixed or minimum level of expenditure;

7 (D) ~~(4)~~ Acquisition of any capital item not for primary and direct use by
8 children;

9 (E) ~~(5)~~ Acquisition (other than by lease for a term of ten years or less) of
10 any real property; or

11 (F) ~~(6)~~ Maintenance, utilities or any similar operating costs of any facility
12 not used primarily and directly by children, or of any recreation or park facility (including a zoo),
13 library, or hospital;:-

14 (G) Administration of funds other than the Fund.

15 (2) Notwithstanding subsection (e), services for Disconnected Transitional-Aged
16 Youth 18 to 24 years-old paid for by the Fund shall not include:

17 (A) Services provided by the Police Department or other law enforcement
18 agencies, the courts, the District Attorney, or the Public Defender, including detention or
19 probation services mandated by state or federal law;

20 (B) Any service for which a fixed or minimum level of expenditure is
21 mandated by local, state or federal law, to the extent of the fixed or minimum level of
22 expenditure;

23 (C) Housing or health services;

24 (D) Income supports; or,

25 (E) Post-secondary tuition assistance or similar aid.

1 (g) **Baseline.** The Fund shall be used exclusively to increase the aggregate City
2 appropriations and expenditures for those services for children that are eligible to be paid from
3 the Fund (exclusive of expenditures mandated by state or federal law). To this end, the City
4 shall not reduce the amount of such City appropriations for eligible services (not including
5 appropriations from the Fund and exclusive of expenditures mandated by state or federal law) ~~in~~
6 ~~any of the fifteen years during which funds are required to be set aside~~ under this section below
7 the amount so appropriated for the fiscal year 2000-2001 ("the base year") as set forth in the
8 Controller's baseline budget, as adjusted ("the base amount"). The base amount shall be adjusted
9 for each year after the base year by the Controller based on calculations consistent from year to
10 year by the percentage increase or decrease in aggregate City and County discretionary revenues.
11 In determining aggregate City and County discretionary revenue, the Controller shall only
12 include revenues received by the City and County that are unrestricted and may be used at the
13 option of the Mayor and the Board of Supervisors for any lawful City purpose. The method used
14 by the Controller to determine discretionary revenues shall be consistent with method used by
15 the Controller to determine the Library and Children's Baseline Calculations dated June 20,
16 2000, which the Controller shall place on file with the Clerk of the Board in File No. 000952.
17 Errors in the Controller's estimate of discretionary revenues for a fiscal year shall be corrected by
18 an adjustment in the next year's estimate. Within 90 days following the end of each fiscal year
19 through 2015-2016 ~~2014-2015~~, the Controller shall calculate and publish the actual amount of
20 City appropriations for services for children that would have been eligible to be paid from the
21 Fund but are paid from other sources, separately identifying expenditures mandated by state or
22 federal law.

23 (h) Five-Year Planning Cycle. The City shall appropriate monies from the Fund
24 according to a five-year planning process. This process is intended to: (1) increase
25 transparency, accountability, and public engagement; (2) provide time and opportunities for

1 community participation and planning; (3) ensure program stability; and (4) maximize the
2 effectiveness of the services funded.

3 (1) Year 1 - Community Needs Assessment. During every fifth fiscal year
4 beginning with Fiscal Year 2016-2017, DCYF shall conduct a Community Needs Assessment
5 (CNA) to identify services to receive moneys from the Fund. DCYF shall use the following
6 process to develop the CNA:

7 (A) By August 15, DCYF shall develop a plan for how to conduct the
8 CNA. The process for conducting the CNA shall include:

9 (i) Community meetings in each Supervisorial District;

10 (ii) A review of major planning documents for children and youth
11 services;

12 (iii) Opportunities for parents, youth, nonprofit agencies, and
13 other members of the public, to provide input; and,

14 (iv) Public notice and outreach to places where parents, children,
15 and youth regularly go, such as recreation centers, bus stops, pediatrician offices, and schools.

16 (B) The CNA shall include an equity analysis of services and resources
17 for parents, children and youth. DCYF shall develop a set of equity metrics to be used to
18 establish a baseline of existing services and resources in low-income neighborhoods and
19 disadvantaged communities, compared to services and resources available to the City as a
20 whole.

21 (C) By September 1, DCYF shall present its plan for conducting the CNA
22 to the Commission, the Provider Advisory Committee, and Board of Supervisors. The plan shall
23 be a public document.

24 (D) By February 1, DCYF shall complete the CNA and present a draft
25 report on the results to the Commission, the First Five Commission, the Service Provider

1 Advisory Committee, and the Recreation and Parks, Health, Human Services, Youth, Juvenile
2 Probation, Status of Women, Police, Library, and Arts Commissions.

3 (E) By May 15, DCYF shall submit a final report on the CNA to the
4 Commission and the Board of Supervisors. The final report may incorporate any comments or
5 suggestions made by the public or by the agencies that received copies of the draft report.

6 (F) By June 1, the Commission shall consider and approve or disapprove
7 the report on the CNA. If the Commission disapproves the report, DCYF may modify and
8 resubmit the report.

9 (G) By July 1, the Board of Supervisors shall consider and approve or
10 disapprove, but not modify, the report on the CNA. If the Board disapproves the report, DCYF
11 may modify and, with the approval of the Commission, resubmit the report, provided, however,
12 that the City may not expend monies from the Fund until the Board of Supervisors has approved
13 a final report on the CNA.

14 (2) Year 2 – Services and Allocation Plan. During every fifth fiscal year
15 beginning with Fiscal Year 2017-2018, DCYF shall prepare a SAP to determine services eligible
16 to receive moneys from the Fund. DCYF shall use the following process to prepare the SAP:

17 (A) By January 31, DCYF shall prepare a draft SAP in consultation with
18 interested City departments, including the First Five Commission, the Office of Early Care and
19 Education (or any successor entity), Recreation and Parks, Health, Human Services, Youth,
20 Juvenile Probation, Status of Women, Police, Library, and Arts Commission, as well as
21 community-based service providers, parents, children, youth, and other members of the public.

22 The SAP must:

23 (i) Demonstrate consistency with the CNA and with Citywide
24 vision and goals for children and families;

25 (ii) Include all services for children and youth;

1 (iii) Be outcome-oriented and include goals, measurable and
2 verifiable objectives and measurable and verifiable outcomes;

3 (iv) Include evaluation of services and capacity building as
4 separate funding areas;

5 (v) State how services will be coordinated and have specific
6 amounts allocated towards specific goals, service models, populations and neighborhoods

7 (vi) Include funding for youth-initiated projects totaling at least
8 3 percent of the total proposed expenditures from the Fund for the cycle;

9 (vii) Include evaluation data from the previous funding cycle and
10 the details of the Children and Youth Baseline; and,

11 (viii) Include strategies to align all services for children furnished
12 or funded by all governmental or private entities and administered by the City, whether or not
13 those services are eligible to receive monies from the Fund.

14 (B) The SAP shall include an equity analysis of services and resources for
15 parents, children and youth. Using the equity metrics developed for preparation of the CNA, the
16 SAP shall compare proposed new and augmented services and resources for low-income
17 neighborhoods and disadvantaged communities with services and resources available to the City
18 as a whole.

19 (C) By February 1, DCYF shall present the draft SAP to the Commission
20 and the Service Provider Advisory Committee. By March 31, DCYF shall present the draft SAP
21 to the Recreation and Parks, Health, Human Services, Youth, and Juvenile Probation
22 Commissions.

23 (D) By May 15, DCYF shall submit a final version of SAP to the
24 Commission and the Board of Supervisors. The final version may incorporate any comments or
25 suggestions made by the public or by the agencies that received copies of the draft SAP.

1 (E) By June 1, the Commission shall consider and approve or disapprove
2 the SAP. If the Commission disapproves the SAP, DCYF may modify and resubmit the SAP.

3 (F) By July 1, the Board of Supervisors shall consider and approve or
4 disapprove, but not modify, the SAP. If the Board disapproves the SAP, DCYF may modify and,
5 with the approval of the Commission, resubmit the SAP, provided, however, that the City may
6 not expend monies from the Fund until a SAP has been approved by the Board of Supervisors.

7 (G) During subsequent years of the planning cycle, DCYF, with the
8 approval of the Commission and the Board of Supervisors, may amend the SAP to address
9 emerging needs.

10 (3) Year 3 – Selection of Contractors. During every fifth fiscal year beginning in
11 2018-2019, DCYF shall conduct competitive solicitations for services to be funded from the
12 Fund.

13 (4) Year 4 – Service Cycle Begins. Contracts for services shall start on July 1 of
14 Year 4 of the planning cycle. During subsequent years of the planning cycle, DCYF, with the
15 approval of the Commission, may issue supplemental competitive solicitations to address
16 amendments to the SAP and emerging needs. All expenditures for services from the Fund must
17 be consistent with the most recent CNA and SAP.

18 ~~(h) Three-Year Planning Cycle. To provide time for community participation and~~
19 ~~planning, and to ensure program stability, appropriations from the Fund for all fiscal years~~
20 ~~beginning after June 30, 2004 shall be made pursuant to a three-year planning cycle as set forth~~
21 ~~in subsections (h) through (l). During every third fiscal year beginning with the 2001-2002~~
22 ~~fiscal year, the City shall prepare a Community Needs Assessment to determine services eligible~~
23 ~~to receive moneys from the Fund. During every third fiscal year beginning with the 2002-2003~~
24 ~~fiscal year, the City shall prepare a Children's Services and Allocation Plan ("the Plan"), based~~
25 ~~on the Community Needs Assessment approved during the previous year. The Board of~~

1 ~~Supervisors may modify an existing Community Needs Assessment or Plan, provided that any~~
2 ~~modification shall occur only after a noticed public hearing. All appropriations from the Fund~~
3 ~~shall be consistent with the most recent Plan, provided that the Board of Supervisors may~~
4 ~~approve an amendment to the Plan at the same time it approves an appropriation.~~

5 ~~(i) **Community Needs Assessment and Children's Services and Allocation Plan.**~~

6 ~~(1) The Community Needs Assessment and the Plan shall be in writing, shall be~~
7 ~~made available to the public in draft form not later than January 31 of each fiscal year in which~~
8 ~~they are required, shall be presented by March 31 of each such fiscal year to the commissions~~
9 ~~listed in subsection (m)(3) for review and comment, and by April 30 of each such fiscal year~~
10 ~~shall be presented to the Board of Supervisors for approval.~~

11 ~~(2) Prior to preparation of each draft Community Needs Assessment, the City~~
12 ~~shall hold at least one public hearing in each geographical area defined in Charter~~
13 ~~Section 13.110. The City shall also make available opportunities for parents, youth, and~~
14 ~~agencies receiving monies from the Fund to provide information for the Community Needs~~
15 ~~Assessment. The Community Needs Assessment shall include the results of a Citywide survey of~~
16 ~~parents and youth to be conducted by the Controller every three years.~~

17 ~~(3) The Plan shall include all services for children furnished or funded by the~~
18 ~~City or funded by another governmental or private entity and administered by the City, whether~~
19 ~~or not they received or may receive monies from the Fund. The Plan shall be outcome-oriented~~
20 ~~and include goals, measurable and verifiable objectives and measurable and verifiable~~
21 ~~outcomes.~~

22 ~~(4) The Plan shall state how all services receiving money from the Fund will be~~
23 ~~coordinated with other children's services. The Plan shall specify amounts of funding to be~~
24 ~~allocated: (i) toward achieving specified goals, measurable and verifiable objectives and~~
25 ~~measurable and verifiable outcomes, (ii) to specified service models; and (iii) for specific~~

1 ~~populations and neighborhoods. The Plan shall also state the reasons for the allocations and~~
2 ~~demonstrate how the allocations are consistent with the Community Needs Assessment. A~~
3 ~~minimum of three percent of the funding allocated under the Plan shall be for youth-initiated~~
4 ~~projects.~~

5 ~~(i) (f) **Evaluation.** DCYF shall provide for the evaluation on a regular basis of all~~
6 ~~services funded through the Fund, and shall prepare on a regular basis an Evaluation and Data~~
7 ~~Report for the Commission. The Plan shall include an evaluation of services that received~~
8 ~~money from the Fund at any time during the last three fiscal years. The evaluation shall involve~~
9 ~~those who use the funded services and other parents and youth.~~

10 ~~(j) **Coordination of Services, Planning and Goals.** The Commission, in consultation~~
11 ~~with the Mayor and other relevant planning bodies, shall issue an annual report on the~~
12 ~~integration of social, health, employment, educational, law enforcement, cultural and recreation~~
13 ~~services for children, youth and their families in San Francisco, which report shall include~~
14 ~~information from all relevant City departments and policy-making bodies.~~

15 ~~(k) **Failure of Board to Act.** If the Board of Supervisors has not approved a Community~~
16 ~~Needs Assessment before the first day of the fiscal year during which the Plan is to be prepared,~~
17 ~~the Plan shall be based on the Community Needs Assessment as originally submitted to the~~
18 ~~Board of Supervisors.~~

19 ~~(k) (f) **Selection of Contractors.** The Commission shall adopt standards and procedures~~
20 ~~for the selection of contractors to be funded from the Fund. It shall be the policy of the City to~~
21 ~~use competitive solicitation processes where appropriate and to give priority to the participation~~
22 ~~of non-profit agencies. Except for services provided by City employees, the Fund shall be~~
23 ~~expended through contractors selected based on their responses to one or more requests for~~
24 ~~proposals issued by the City. The City shall award contracts to coincide with the City's fiscal~~
25 ~~year starting July 1.~~

1 (l) (m) Implementation.

2 (1) In implementation of this section, facilitating public participation and
3 maximizing availability of information to the public shall be primary goals.

4 (2) ~~So long as there exists within the executive branch of City government a~~

8 Children, Youth and Their Families ("DCYF"), to oversee the administration of the Children

LEGISLATIVE DIGEST

[Charter Amendment - Children and Youth Fund; Commission on Children, Youth, and Their Families]

A proposal to the qualified voters of the City and County of San Francisco to amend the Charter of the City and County of San Francisco at an election to be held on November 4, 2014, by amending Section 16.108, adding a new Section 4.133, and repealing former Sections 4.133 and 16.108, to: (1) renew and rename the Children's Fund and eliminate the Fund's expiration date; (2) increase the property tax set-aside for the Fund from three cents per \$100 of assessed valuation to five cents; (3) provide for services for at-risk youth 18 to 24 years old; (4) revise and expand the planning process for expenditures from the Fund; (5) modify the advisory committee for the Fund; (6) create a Commission on Children, Youth and Their Families; and (7) repeal an obsolete provision of the Charter.

Existing Law

In 1991, the voters first created in the City Charter a "Children's Fund," which receives a set portion of the property tax each year. The current amount of the set-aside is 3 cents for each \$100 of assessed property value. The Children's Fund is used to increase services for children under 18 years of age, including child care, health services, job training, social services, educational programs, recreational and cultural programs, and delinquency prevention services.

The Department of Children, Youth and Their Families, which reports to the Mayor, administers the Children's Fund. The Mayor also appoints a 15-member Children's Fund Advisory Committee. The Charter sets a three-year planning cycle for spending money from the Children's Fund.

The Children's Fund and the property tax set-aside will expire on June 30, 2016.

Amendments to Current Law

The proposal is a Charter amendment that would change the name of the Fund from "the Children's Fund" to "the Children and Youth Fund."

The proposal would eliminate the current provision that the Fund and the property tax set-aside will expire on June 30, 2016. Under the proposal, the Fund and the property tax set-aside would continue until changed or repealed by the voters.

The proposal would increase the property tax set-aside from the current 3 cents for each \$100 of assessed property value to 5 cents for each \$100 of assessed property value. The proposal would not increase or otherwise change the property tax rate; it would only affect how the tax may be spent.

The proposal would allow the City to use the Fund to provide services to “Disconnected Transitional-Aged Youth,” as well as to continue to provide services to children younger than 18 years. “Disconnected Transitional-Aged Youth” are youth, 18 to 24 years old, who: are homeless or in danger of homelessness; have dropped out of high school; have a disability or other special needs, including substance abuse; are young, unmarried parents; are undocumented; are immigrants and/or English Learners; are Lesbian, Gay, Bisexual, Transgender, Queer, and Questioning (“LGBTQQ”); and/or are transitioning from the foster care, juvenile justice, criminal justice or special education systems.

The proposal would change the current three-year planning cycle for spending from the Fund to a five-year cycle, and set out additional steps in the cycle.

The proposal would replace the current Advisory Committee for the Fund with a new Service Provider Advisory Committee.

The proposal would create a seven-member Commission on Children, Youth and Their Families to oversee the Department of Children, Youth and Their Families and to administer the Children and Youth Fund. The Mayor and the Board of Supervisors would appoint the members of the Commission.

And the proposal would repeal Charter Section 4.133, which created the Taxi Commission. The Board of Supervisors and the Mayor dissolved the Taxi Commission and transferred its functions to the Municipal Transportation Agency in 2008 under Charter Section 8A.101(b). But because Section 4.133 was approved by the voters, the City needs voter approval to remove it from the Charter, even though it no longer is law.

Dear Board of Supervisors:

San Francisco has been at the forefront of seeking true equity for girls and women since 1998 with the adoption of the City Ordinance implementing the UN Convention of the Elimination of All Forms of Discrimination Against Women (CEDAW). The San Francisco CEDAW Ordinance specially calls on the City and County to analyze the operations of City departments, policies and programs to identify discrimination in the provision of direct and indirect services and, if identified, to remedy that discrimination.

Even today, women and girls continue to face subtle but harmful discrimination in the areas of economic development and employment, violence against women and girls, and health. The Department finds that the unique concerns of girls have too often not received due attention, funding, and analysis. Indeed, very few programs in San Francisco respond specifically to the needs of girls and young women. For instance, young women disproportionately face problems with body dysmorphia and sexual violence, problems that are not effectively addressed in co-ed settings. The programs that attempt to address broad youth concerns that do not take into account the different needs of girls (broken down by race and economic status) or that do not collect data to uncover the specific needs of girls, fail to address the concerns of all youth in an equitable fashion. Girls and young women are at a particularly vulnerable point in their development as citizens and human beings. Legislation like the Children and Youth Fund can have a particular influence over their development and sense of self-worth.

Throughout this Children and Youth Fund reauthorization, "equity" has been highlighted as a significant new principle to be adhered to during the funding and allocation processes. It is critical that gender equity serve as one component of this principle. Girls' advocates have been successful in incorporating more gender-responsive language in this latest draft (e.g., "ensuring children are provided with gender-responsive and culturally-competent services" and "Services responsive to issues of gender, sexual orientation, and gender identification, including, but not limited to, services to address the needs of girls and LGBTQQ communities"). However, three more changes would have a substantially positive impact not just for the girls and young women of San Francisco, but for all children.

The Department makes the following (2) recommendations for the second draft of the Children and Youth Fund Charter Amendment, File No. 140441:

i. Sec. 16.108(h)(1B): Gender equity included in the paragraph regarding equity metrics for the C.N.A. equity analysis in addition to low-income neighborhoods and disadvantaged communities.

It is critical that metrics are identified to establish a baseline for the status of girls and young women, and to monitor progress with the inclusion of the new guiding principle. Metrics and data should be disaggregated by sex as well as by race, socioeconomic status, gender identify, and so forth.

ii. Sec. 16.108(l)(3): Require the Commission on the Status of Women to hold one separate or joint Children and Youth Fund hearing once per fiscal year.

To ensure girls' voices are heard at all steps throughout the Children and Youth Fund process, the Commission on the Status of Women (COSW) should also be tasked with holding at least one separate or joint hearing on the fund along with the Recreation and Park, Juvenile Probation, Youth, Health and Human Services Commissions.


The Department makes the following recommendation for the second draft of the Children and Families Council Charter Amendment, File No. 140443:

i. Sec. 16.126(a)(5) and (c): Reserve one seat on the Children and Families Council for the Department on the Status of Women to ensure the equitable representation of girls' needs.

Now that gender-responsive services are explicitly included in the Children and Youth Fund draft language, it is all the more important that an individual with the knowledge and ability to oversee this provision has a seat on the Council. The Department should be identified as one of the stakeholders with responsibilities for services to children and family, and the Department's Executive Director should be given a seat on the Council.

At our regular meeting of Monday, May 5th, 2014 the Youth Commission voted unanimously to support the following motion:

To support BOS File No. 140441, Charter Amendment to amend the Charter, Section 16.108, adding a new Section 4.133, and repealing former Section 4.133, to: 1) renew and rename the Children's Fund and eliminate the Fund's expiration date; 2) increase the property tax set-aside for the Fund from three cents per \$100 of assessed valuation to five cents; 3) provide for services for at-risk youth 18 to 24 years old; 4) revise and expand the planning process for expenditures from the Fund; 5) modify the advisory committee for the Fund; 6) create a Commission on Children, Youth and Their Families; and 7) repeal an obsolete section of the Charter.

During discussion on this item, the Youth Commission proposed and approved the following comment and recommendations regarding this item:

- We urge the Board of Supervisors to consider our recommendations for the Children's Fund adopted in our resolution 1314-04 Policies and Priorities for the

Children's Fund" on April 7th, 2014. We would like to restate these policy recommendations: 1) allowing the use of the fund for transitional age youth (TAY) to be served by existing youth-serving community programs and for specific needs of disconnected TAY; 2) reserving 25% of seats on any body that is in charge of Children's Fund oversight for youth, with half of the total youth seats represented by youth under 18 years old and the other half represented by disconnected TAY. These seats should be appointed and supported by the SF Youth Commission; 3) proactively supporting and facilitating better coordination between the City, the San Francisco Unified School District (SFUSD), and community based organizations serving youth by increasing the sharing of cultural competency best practices, making available complementary spaces for youth programs to convene youth town halls and meetings, and considering other potential points of collaboration; 4) resourcing youth leadership groups to design and facilitate annual youth town halls to identify their unmet needs, and to evaluate the programs and services they receive as part of the Community Needs Assessment and evaluation plan; 5) increasing the fund allowing services to provide for and support the unmet needs of youth, including disconnected TAY population.

- We also identified the following unmet services that should be prioritized and expanded in the Children's Fund: 1) increase dedicated services, support, and employment opportunities for undocumented youth; 2) extend mentoring programs currently provided to juvenile detainees and probationers to transitional aged youth in the adult probation system; 3) increase support for 17 and 18 year olds transitioning between juvenile and adult systems, including support interviewing for eligibility for release and entry into diversion programs and community programs used as sentencing alternatives.
- We would also like to recommend including stipends for all members of the proposed Commission on Children, Youth, and their Families. The Youth Commission is unique among city commissions in not having stipends for commissioners and it has posed challenges in maintaining diversity of representation and posed barriers to involvement for several qualified young people.

File No. 140441 Children and Youth Fund; Commission on Children, Youth, and Their Families

Charter Amendment (First Draft) to amend the Charter, Section 16.108, adding a new Section 4.133, and repealing former Section 4.133, to: 1) renew and rename the Children's Fund and eliminate the Fund's expiration date; 2) increase the property tax set-aside for the Fund from three cents per \$100 of assessed valuation to five cents; 3) provide for services for at-risk youth 18 to 24 years old; 4) revise and expand the planning process for expenditures from the Fund; 5) modify the advisory committee for the Fund; 6) create a Commission on Children, Youth and Their Families; and 7) repeal an obsolete section of the Charter.

Please review immediately and prepare a financial analysis of the proposed measure prior to the first Rules Committee hearing.


