

1 [Preparation of findings related to the categorical exemption issued for the Medical Cannabis
2 Dispensary ordinances.]

3 **Motion directing the Clerk of the Board to prepare findings related to the appeal of the**
4 **determination by the Planning Department that the Medical Cannabis Dispensary**
5 **ordinances are categorically exempt from environmental review under the California**
6 **Environmental Quality Act.**

8 WHEREAS, The Environmental Review Office of the San Francisco Planning
9 department issued a certificate of determination of exemption/exclusion from environmental
10 review for the Medical Cannabis Dispensary ordinances on August 25, 2005 (the
11 "determination). A copy of said document is on file with the Clerk of the Board of Supervisors
12 in File No.051801, and is incorporated by reference herein; and,

14 WHEREAS, By letter to the Clerk of the Board of Supervisors dated October 21, 2005,
15 Bill Barnes ("Appellant") filed an appeal of the determination to the Board of Supervisors,
16 which the Clerk of the Board of Supervisors received on or around October 21, 2005; and,

18 WHEREAS, On November 15, 2005, this Board held a duly noticed public hearing to
19 consider the appeal of the determination. Following the conclusion of the public hearing, the
20 Board rendered a decision on the use of the exemption/exclusion for the project based on the
21 written record before the Board in File No. 051801 which is hereby declared to be a part of
22 this motion as if set forth fully herein, as well as all of the testimony at the public hearing in
23 support of and opposed to the appeal; and,

25 WHEREAS, In regard to said decision, this Board made certain findings specifying the
basis for its decision; now, therefore, be it
