3 **Ordinance amending the San Francisco Administrative Code, by amending**
4 **Section 10G.1, to apply the Board of Appeals surcharge to certain permits renewals**
5 **issued by the Police Department, the Entertainment Commission, and the Taxi**
6 **Commission under Police Code Sections 2.27 and 2.27.1, and making environmental**
7 **findings.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The San Francisco Administrative Code is hereby amended by amending
14 Section 10G.1, to read as follows:

15 **SEC. 10G.1. SURCHARGE IMPOSED; CATEGORIES OF PERMITS AND FEES.**

16 In order to recover the cost to the City and County for the Board of Appeals permit
17 review functions, at the time a fee for permit application, issuance, or review is collected, a
18 surcharge in the amount specified shall be charged and collected for the following categories
19 of permits and fees.

20 (a) For fees imposed by the Department of City Planning pursuant to San Francisco
21 Planning Code Sections 351(h), 352(a), (except for fees imposed for hearings on Conditional
22 Uses under Section 303 or Planned Unit Developments under Section 304), 353(a), 353(b),
23 353(c), or 355 for review of permits that may be appealed to the Board of Appeals pursuant to
24 Charter Section 4.106, a surcharge of \$11.00 ~~\$10.00~~;

1 (b) For permits issued pursuant to San Francisco Building Code Section 110: Tables
2 1-A, 1-F, Item 3, 1-H, 1-K, Item 8, or 1-Q, Item 5 that may be appealed to the Board of
3 Appeals pursuant to Charter Section 4.106, a surcharge of \$11.00 ~~\$10.00~~;

4 (c) For permits issued pursuant to the San Francisco Public Works Code that may be
5 appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of \$1.00;

6 (d) For permits issued pursuant to San Francisco Police Code Section 2.26 that may
7 be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of \$8.00
8 ~~\$7.00~~;

9 (e) For permits issued pursuant to San Francisco Police Code Section 2.26.1 that may
10 be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of \$3.00
11 ~~\$9.00~~.

12 (f) For permits renewals issued pursuant to San Francisco Police Code Section 2.27 that may
13 be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of \$3.00;

14 (g) For permits renewals issued pursuant to San Francisco Police Code Section 2.27.1 that
15 may be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of \$3.00.

17 Section 2. The Planning Department has determined that the actions contemplated in
18 this Ordinance are in compliance with the California Environmental Quality Act (California
19 Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk
20 of the Board of Supervisors in File No. _____ and is incorporated herein by this
21 reference.
