- 6. Has the Department verified the assumptions it made regarding how electric demand would increase in the Downtown Plan EIR?
- 7. Isn't it appropriate to immediately make all server farms a Conditional Use so that the City can monitor them and impose appropriate conditions, such as requiring maximum energy efficiency by use of the least energy intensive technology?
- 8. Would someone from the Department please visit the site of the 1828 Egbert Street server farm, currently under construction next to several dozen residences, and come prepared to explain how that enormously out-of-scale facility ever made it through the Planning Department.
- 9. Has anyone analyzed the impacts of the electrical field created when such huge electrical facilities are next to residences? If there are 1,000,000 square feet of server farms on two adjacent blocks near people's homes in Bayview, what type of interference is likely to occur on such things as cell phones, radio and television reception, and most importantly people's health?
- 10. The Negative Declarations discuss job reductions at most of these sites. Does the Department have any information on how many jobs are in the new facilities versus how many jobs were in the former facilities on these sites?
- 11. What steps has the Department taken to draw an appropriate radius around the proposed Potrero power plant site to ensure that residences are not constructed too close to that plant? How close to that facility is the 175-unit live/work project proposed on Illinois Street? Why is housing and live/work allowed down to 25th & Illinois when that is so near the power plant?
- 12. How will the Department be handling utility installations, including server farms, in the rezoning controls for industrial areas? When will the draft be available?
- 13. When I was campaigning, people near the Egbert facility told me that they had gotten no notice of that enormous building, which looms over residences literally 10 feet away. Would you please provide me with all notice lists for the Egbert and 200 Paul facilities already approved, as well as for the Newhall and 400 Paul facilities currently being reviewed.
- 14. Is a server farm or other utility installation being reviewed for the former Downtown Rehearsal Studios site at 5700 3rd Street, a site which is about 1000 feet from the 200 Paul site?

- 1) Requesting/Inquiring: To provide recently issued Preliminary Negative Declarations for the proposed "server farms" at 2660 Newhall Avenue and for 400 Paul Avenue.

3) Supervisor Maxwell has been informed that none of those Negative Declarations has an analysis of the amount of power consumed in those facilities, nor any cumulative analysis of power demand. And that although there are at least four such facilities on adjacent blocks - 1828 Egbert, 2660 Newhall, 200 Paul and 400 Paul - and that those facilities are adjacent to residences, there is no analysis of cumulative impacts from such huge electrical facilities on nearby residents or of the cumulative power demand in that neighborhood. Supervisor Maxwell inquires of Ms. Gitelman whether it would not be wise to amend the 2660 Newhall and 400 Paul Preliminary Negative Declarations now to provide that information rather than waiting until there is an appeal.
