11 MOVED, That the Board of Supervisors of the City and County of San Francisco
12 amends Rule 5.37 of the Rules of Order of the Board, to read as follows:

13 5.37 Filing Inactive Matters After Six Months; Filing Proposed Charter Amendments Not
14 Placed On The Ballot. If a measure (other than a Charter amendment) or a hearing request
15 referred to committee has not been heard by the committee for any five consecutive calendar
16 months, the Clerk of the Board shall note on the next committee pending list that unless the
17 item is heard the following month it is deemed to be inactive and shall be filed by the Clerk of
18 the Board, who shall make an appropriate note on the legislative history record of such filing.
19 San Francisco Elections Code, Section 300, provides that proposed Charter amendments the Board
20 wishes to submit to the voters may be submitted for the next election held no fewer than 102 days after
21 the date of submission, and allows the Director of Elections to accept from the Board one proposed
22 Charter amendment a week later, but no fewer than 95 days before the date of an election. On the 94th
23 day prior to each City and County election, the Clerk of the Board shall file all pending proposed
24 Charter amendments that have not been submitted to the voters by the Board for that election.
