AUTHORIZING THE MAYOR'S CRIMINAL JUSTICE COUNCIL (MCJC) TO RETROACTIVELY APPLY, ACCEPT AND EXPEND FUNDS IN THE AMOUNT OF \$544,744 FROM THE OFFICE OF CRIMINAL JUSTICE PLANNING (OCJP), STATE OF CALIFORNIA, FROM FUNDS MADE AVAILABLE UNDER THE JUVENILE ACCOUNTABILITY INCENTIVE BLOCK GRANT (JAIBG).

WHEREAS, the Juvenile Justice Coordinating Council of San Francisco has determined that that MCJC shall be the lead programmatic and fiscal agency for this program and will distribute funding to address the issues of juvenile crime and violence under the required federal purpose areas to the following city departments: Juvenile Probation; Police; Public Defender; Superior Court; Public Health; Department of Children, Youth and Their Families; and the Mayor's Criminal Justice Council; and,

WHEREAS, that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and OCJP disclaim responsibility for any such liability; and,

WHEREAS, it is anticipated that this Juvenile Accountability Incentive Block Grant funding will be available again, based on federal appropriations, in the next fiscal year(s) at the same estimated award amount, it is requested that this resolution approve and authorize MCJC to apply, accept and expend for those anticipated funds accordingly;

WHEREAS, the entire award by the OCJP funds direct services, it is requested that indirect costs be waived; now, therefore, be it

RESOLVED, That the City and County of San Francisco hereby authorizes MCJC to retroactively apply, accept and expend \$544,744 from the OCJP, State of California, to implement the Juvenile Accountability Incentive Block Grant Program this fiscal year and for the following year(s) subject to federal appropriations; and, be it

FURTHER RESOLVED, That the two new positions authorized under the grant for the Public Defender's Office shall be designated as "G" or "Grant-funded" positions, KIMIKO BURTON which would terminate when the grant expires. DIRECTOR, MCJC
