AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, POPULATION HEALTH AND PREVENTION DIVISION, TO ENTER RETROACTIVELY INTO A SUBCONTRACT IN THE AMOUNT OF \$4,565 WITH THE UNIVERSITY OF CALIFORNIA URBAN HEALTH STUDY, THE PRIMARY CONTRACTOR, TO PROVIDE DATA MANAGEMENT SERVICES FOR THE URBAN HEALTH STUDY WHICH DOES NOT INCLUDE PATENT INFRINGEMENT INDEMNIFICATION AND FALSE CLAIMS CLAUSES; WAIVING INDIRECT COSTS; PROVIDING FOR RATIFICATION OF ACTION PREVIOUSLY TAKEN.

WHEREAS, The Robert Wood Johnson Foundation has awarded funds to the University of California, San Francisco Urban Health Study for a grant entitled "The Impact of Treatment on Demand on Injection Drug Users in the San Francisco Bay Area"; and,

WHEREAS, The University of California Urban Health Study has awarded a subcontract from the above named grant to The Department of Health, City and County of San Francisco in the amount of \$4,565 in first year funding to support the activities of Alice Gleghorn, Ph.D., in providing data management services for this grant; and,

WHEREAS, As a condition of receiving the funds, the University of California requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 991220 ; and

WHEREAS, The University of California has indicated that it will not agree to any modification to the form of the Agreement; and,

WHEREAS, The Agreement does not contain certain provisions described below, which are required under the Administrative Code unless waived by the Board of Supervisors; now, therefore, be it

RESOLVED, That the San Francisco City and County Department of Public Health is hereby authorized to enter into a subcontract in the amount of \$4,565 with the University of California Urban Health Study, the Primary Contractor; retroactive to July 1, 1999; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement  
2 contained in Sections 6.21 and 21.19 of the Administrative Code that the Agreement include an  
3 indemnification of the City by The Regents of the University of California for the infringement of patent  
4 rights; and, be it


5 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement  
6 contained in Section 6.57(c) of the Administrative Code that the Agreement include a paragraph reciting  
7 the false claim provisions contained in Section 6.57(a) of the Administrative Code; and, be it

8 FURTHER RESOLVED, That the Board of Supervisors does hereby waive indirect costs; and,  
9 be it

10 FURTHER RESOLVED, That although the City has incurred no legal obligation, the Board of  
11 Supervisors does hereby ratify the action previously taken; and, be it


12 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Public Health  
13 to enter into similar agreements with the University of California if the contract recurs or is renewed.




