4 **Resolution approving Award of Professional Services Agreement for Airport Contract**
5 **No. 50240 to operate, maintain, and repair Airport-owned passenger boarding bridges**
6 **and baggage handling systems in the domestic terminals, between Professional**
7 **Business Providers, Inc., and the City and County of San Francisco, acting by and**
8 **through its Airport Commission, in an amount not to exceed \$13,114,615 pursuant to**
9 **Charter, Section 9.118(b), for the period of August 1, 2022, through July 31, 2025.**

11 WHEREAS, On May 17, 2022, pursuant to Resolution No. 22-0080, the Airport
12 Commission awarded the Professional Services Agreement – to operate, maintain, and
13 repair Airport-owned passenger boarding bridges and baggage handling systems in the
14 domestic terminals, for a three (3) year term, beginning August 1, 2022, through July 31,
15 2025, in a not to exceed amount of \$13,114,615 with one (1) two-year option, exercisable
16 at the sole discretion of the Airport Commission; and

17 WHEREAS, San Francisco Charter, Section 9.118(b) provides that the agreements
18 entered into by a department, board or commission requiring anticipated expenditures by the
19 City and County of ten million dollars, shall be subject to approval by the Board of Supervisors
20 by Resolution; and

21 WHEREAS, The original contract is on file with the Clerk of the Board of Supervisors in
22 File No. 220656, which is hereby declared to be a part of this Resolution as if set forth fully
23 herein; now, therefore, be it

24 **RESOLVED, That the Board of Supervisors hereby approves the Award of**
25 **Professional Services Agreement for Airport Contract 50240 to operate, maintain, and repair**

1 Airport-owned passenger boarding bridges and baggage handling systems in the domestic
2 terminals between Professional Business Providers, Inc. and the City and County of San
3 Francisco, acting by and through its Airport Commission, for a three (3) year term, at a not to
4 exceed amount of \$13,114,615, with one (1) two-year option, exercisable at the sole
5 discretion of the Airport Commission, copies of which are contained in Board of Supervisors'
6 File No. 220656; and, be it

7 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed
8 by all parties, the Airport Commission shall provide the final contract to the Clerk of the Board
9 for inclusion into the official file.
