3 **Ordinance increasing the licensing fee for garbage trucks and the amount deposited**  
4 **into the Mandatory Refuse Collection Service Fund by amending Section 249.6 of the**  
5 **San Francisco Business and Tax Regulations Code and Section 10.100-7 of the San**  
6 **Francisco Administrative Code and ratifying past actions taken in connection with**  
7 **such licensing fee.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The San Francisco Business and Tax Regulations Code is hereby amended  
14 by amending Section 249.6 to read as follows:

15 **Sec. 249.6. VEHICLES FOR THE TRANSPORTATION OF REFUSE AND**  
16 **ADJUDICATION OF RATE DISPUTES.**

17 Every person, firm or corporation engaged in operating a vehicle for transportation of  
18 refuse or garbage that requires a permit from the Health Department shall pay an annual  
19 license fee to the Tax Collector as follows:

- 20 (a) Garbage truck, ~~\$2,273~~ \$ 3,268.00 for each vehicle.
- 21 (b) Swill trucks, \$78 for each vehicle.

22 The license fees prescribed by this Section are due payable on an annual basis. Fees  
23 for new licenses issued prior to or after January 1<sup>st</sup>, or in any subsequent calendar year, shall  
24 be prorated to January 1<sup>st</sup> on a monthly basis.

1 The fees prescribed by this Section are for the purpose of reimbursing the City and  
2 County of San Francisco for costs incurred in the implementation of the Mandatory Refuse  
3 Collection Program, the inspection and licensing of refuse vehicles and the adjudication of  
4 adjudicating refuse collection rate disputes.

5 Section 2. The San Francisco Administrative Code is hereby amended by amending  
6 Section 10.100-7 to read as follows:

7 Sec. 10.100-7. **ADMINISTRATIVE SERVICES MANDATORY REFUSE**  
8 **COLLECTION SERVICE FUND.**

9 (a) **Establishment of Fund.** The Administrative Services Mandatory Refuse  
10 Collection Service Fund is established as a category seven fund into which shall be deposited  
11 ~~\$955~~ \$1,950.00 of the total annual license fee paid for each permitted garbage truck refuse  
12 collection vehicle pursuant to the provisions of Part III, in accordance with Section 249.6 of the San  
13 Francisco Business and Tax Regulations ~~Municipal~~ Code.

14 (b) **Use of the Fund.** The Mandatory Refuse Collection Service Fund shall be used  
15 exclusively for the enforcement of the provisions of Article 6, Section 290 of the San Francisco  
16 Health Code, to include but not be limited to expenses incurred for personnel, supplies and  
17 equipment necessary for this purpose.

18 (c) **Administration of Fund.** The Department of Public Health Director of  
19 Administrative Services shall file an quarterly annual report regarding the fund, including receipts  
20 and expenditures, with ~~the Mayor, the Board of Supervisors,~~ the Controller ~~and the Budget Analyst.~~

21 (d) The Mandatory Refuse Collection Service Fund shall sunset on June 30, 2003.  
22 Revenues and expenditures associated with said fund shall be transferred to the General Fund to be  
23 appropriated annually by the Board of Supervisors for the purposes specified herein.


