3 **Resolution designating certain intersections as "STOP" intersections.**

5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
6 following intersections are hereby designated as "STOP" intersections, and the Department of
7 Parking and Traffic is hereby authorized and directed to cause "STOP" signs to be installed
8 thereat as designated below:

9 **STOP SIGNS - ESTABLISH**

10 Bocana Street, Wool Street and Powhattan Avenue, installing STOP signs at the
11 Bocana Street, Wool Street and Powhattan Avenue approaches, making this a
12 Three-Way STOP;

12 Peter Yorke Way and Post Street, stopping Peter Yorke Way at Post Street;

13 21st and Hampshire Streets, stopping 21st Street at Hampshire Street, making this
14 intersection an All-Way STOP;

15 Boylston and Sweeny Streets, stopping Boylston Street at Sweeny Street, making this
16 intersection an All-Way STOP;

17 Barneveld and Sweeny Streets, stopping Sweeny Street at Barneveld Street, making
18 this intersection an All-Way STOP; and,

19 44th Avenue and Santiago Street, stopping 44th Avenue at Santiago Street, making
20 this intersection an All-Way STOP.

Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street.




