Dear Supervisor Mar,

The San Francisco Chamber of Commerce, representing hundreds of local businesses and thousands of employees, has reviewed Supervisor Mar's Amendments to the Emergency Resolution for Public Health Emergency Leave (File #200313). The measure, should it pass, would temporarily require private employers with 500 or more employees to provide public health emergency leave during the public health emergency related to COVID-19.

The San Francisco Chamber of Commerce is supportive of this ordinance and its effort to support workers during this critical time. We sincerely thank the Supervisor for his work on this issue, and for working closely with the San Francisco Chamber of Commerce on specifics of the ordinance.

We greatly appreciate the clarity around resolution of emergency hours upon the end of the public health crisis, the addition of voluntary paid leave credit towards the mandate, clarification around temporary worker leave, clarification around definition of healthcare providers, clarification regarding notification on itemized wage statements, and confirmation that companies who offer unlimited leave have met the requirements of this legislation.
