3 **Ordinance authorizing settlement of the lawsuit filed by Lyudmila Maleva against the**
4 **City and County of San Francisco for \$60,000; the lawsuit was filed on March 2, 2023, in**
5 **San Francisco Superior Court, Case No. CGC-23-604902; entitled Lyudmila Maleva v.**
6 **City and County of San Francisco, et al.; the lawsuit involves alleged personal injury on**
7 **a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Lyudmila Maleva v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-604902 by the
13 payment of \$60,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 March 2, 2023, and the following parties were named in the lawsuit: Plaintiff Lyudmila
16 Maleva, Defendant City and County of San Francisco.
