6 WHEREAS, The Advisory Dogs Off-Leash Task Force was established in May, 1998, by
7 the Parks and Recreation Committee of the Board of Supervisors, to assess the use of parks by
8 San Franciscans with their dogs off-leash, to investigate and recommend solutions for improving
9 conditions in City parks, and to determine how best to provide sufficient off-leash opportunities
10 for San Francisco dog owners; and,


