Re: Conditional Approval of Refuse Collection Truck Permit Application for Refuse Collection Trucks pursuant to Contract with Office of Contract Administrator, Sourcing Event #0000006945, to provide refuse collection service to San Francisco City Department Facilities

Dear Ms. Devincenzi,

On November 17, 2023, the San Francisco Department of Public Health ("Department") received the Refuse Collection Truck Application packet ("Application") from Allied Waste Services of North America LLC ("Allied Waste") proposing to operate 14 Refuse Collection Trucks to service approximately 383 San Francisco City Department Facilities ("City Facilities") pursuant to the Contract with the Office of Contract Administrator ("OCA") under the Business Name ("DBA") Republic Services of Daly City. The OCA Contract is currently undergoing solicitation under the Sourcing Event #0000006945. On November 29, 2023, Allied Waste made a correction on the San Francisco Project Planning Application Review upon request by the Department and the document was re-submitted via email the same day. On January 5, 2024, Allied Waste edited the Refuse Collection Truck inventory upon request by the Department and the document was re-submitted via email on January 9, 2024.

The Department has completed its review of the Application and additional requested information and hereby issues Conditional Permit with the following conditions:


- a. The Conditional Permit applies to the specific 14 Refuse Collection Trucks declared on the Refuse Collection Truck Inventory submitted on November 17, 2023. Any changes to the truck specifications must be submitted to the Department prior to the issuance of the official Permit to Operate.
- b. The 14 Refuse Collection Trucks are not allowed to operate until all of the following requirements are completed:
 - i. Submit updated Refuse Collection Truck Inventory Sheet with the following information to the Department:
 1. Designated truck numbers,

2. Business route numbers – Provide specific service address(es) associated with the route number,
 3. Day of Collection, and
 4. Time of Collection.
- ii. Submit a written documentation verifying approval of “San Francisco Project Planning Application for Environmental Review” to the Department.
 - iii. Submit a written documentation verifying approval of the OCA contract to the Department.
 - iv. Obtain inspection of the 14 Refuse Collection Trucks from the Department to verify compliance of applicable local and state standards, including but not limited to, [San Francisco Health Code Article 6](#), [San Francisco Police Code Article 29 Section 2904](#), and [California Code of Regulation, Title 14, Chapter 3, Article 5](#).  - v. Obtain official Health Permit to Operate from the Department.

This document serves as your Conditional Permit. This Conditional Permit is not transferable. The Department will issue an official Permit to Operate upon determining all requirements listed above are met.
