Resolution determining that the transfer of a Type-21 off-sale general beer, wine, and distilled spirits license to Abdalla F. Joseph, doing business as Sav More Market located at 4522-3rd Street (District 10), will serve the public convenience or necessity of the City and County of San Francisco, in accordance with California Business and Professions Code, Section 23958.4.

WHEREAS, Abdalla F. Joseph, doing business as Sav More Market located at 4522-3rd Street (District 10), is seeking the transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license; and

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

WHEREAS, The Police Department has filed zero (0) protests and zero (0) letters of support with the Department of Alcoholic Beverage Control under California Business and Professions Code, Section 24013, and recommends that the Department of Alcoholic Beverage Control issue the liquor license with conditions; and

WHEREAS, The conditions recommended by the Police Department are the following: 1) sales of alcoholic beverages shall be permitted between the hours of 7:00 a.m. to 2:00 a.m. daily; 2) the following alcoholic beverages shall not be sold in quantities of fewer than three (3) individual containers per sale: pre-mixed wine products commonly known as" wine coolers," pre-mixed distilled spirits-based cocktails; 3) no distilled spirits shall be sold in bottles or containers smaller than 50 milliliters; 4) petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as

depicted on the most recently certified ABC-253; and 5) any graffiti painted or marked upon the premises or on any adjacent area under the control of the licensee(s) shall be removed or painted over within 72 hours of being applied; now, therefore, be it

RESOLVED, That in accordance with California Business and Professions Code, Section 23958.4, the Board of Supervisors of the City and County of San Francisco hereby determines that the transfer of a Type-21 off-sale beer, wine, and distilled spirits liquor license to Abdalla F.
