

1 [Apply for, Accept, and Expend Grant - Retroactive - U.S. Department of Housing and Urban  
2 Development - HOME Investment Partnership American Rescue Plan Program - \$18,707,742  
3 - FY2021-2022]

4 **Resolution retroactively approving the Fiscal Year (FY) 2021-2022 HOME Investment**  
5 **Partnership American Rescue Plan (HOME-ARP) Program; and authorizing the Mayor,**  
6 **on behalf of the City and County of San Francisco, to apply for, accept, and expend the**  
7 **City's FY2021-2022 HOME-ARP Program grant from the U.S. Department of Housing**  
8 **and Urban Development in the amount of \$18,707,742 for the term of July 1, 2021,**  
9 **through September 30, 2030.**

11 WHEREAS, Under Title II of the National Affordable Housing Act of 1990, Public Law  
12 Number 101-625, the City and County of San Francisco is eligible to apply for and receive  
13 funds from the HOME Investment Partnership (HOME) Program; and,

14 WHEREAS, Under the American Rescue Plan Act of 2021, the City and County of San  
15 Francisco is eligible to apply for and receive funds from the HOME Investment Partnership  
16 American Rescue Plan (HOME-ARP) Program; and,

17 WHEREAS, The City and County of San Francisco anticipates receiving approximately  
18 \$18,707,742 in 2022 HOME-ARP Program funds from HUD; and,

19 WHEREAS, The Mayor's Office of Housing and Community Development (MOHCD)  
20 has prepared programs and a proposed Expenditure Schedule for an anticipated grant of  
21 \$18,707,742, a copy of which is located in Clerk of the Board of Supervisors File No. 220430  
22 (the "Expenditure Schedule"); and,

23 WHEREAS, The proposed grant does not require an Annual Salary Ordinance  
24 amendment; and,

1           WHEREAS, The funding agency (HUD) does not allow use of grant on indirect costs;  
2 and,

3           WHEREAS, The HOME-ARP Program will be used to provide funds for development of  
4 homeless permanent supportive housing; and,

5           WHEREAS, A portion of the administrative and direct costs of administering the  
6 HOME-ARP Program are to be paid from the Fiscal Year (FY) 2021-2022 HOME-ARP  
7 Program allocation; and,

8           WHEREAS, The remainder of the administrative and direct costs of administering the  
9 HOME-ARP Program is an eligible Community Development Block Grant (CDBG) expense,  
10 and will be paid from CDBG funds through the FY2021-2022 CDBG Program; now, therefore,  
11 be it

12           RESOLVED, That the Mayor of the City and County of San Francisco is hereby  
13 authorized to apply for, accept, and expend the City's FY2021-2022 HOME-ARP Program  
14 grant from HUD, all in accordance with the purposes and goals for the funding as generally  
15 set forth in the 2020-2024 Five Year Consolidated Plan and the Expenditure Schedule; and,  
16 be it

17           FURTHER RESOLVED, That the Board of Supervisors does hereby approve the  
18 purposes and goals for FY2021-2022 HOME-ARP Program funding as set forth in the  
19 Expenditure Schedule; and, be it

20           FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
21 indirect costs in the grant budget; and, be it

22           FURTHER RESOLVED, That the Mayor is hereby authorized to enter into and execute  
23 agreements between the City and County of San Francisco and the various agencies  
24

1 consistent with the FY2021-2022 HOME-ARP Program and the Expenditure Schedule; and,  
2 be it

3           FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation  
4 and certifications as may be requested or required by HUD, and to take such additional  
5 actions as may be required to apply for, accept and expend the FY2021-2022 HOME-ARP  
6 funds consistent with this Resolution and the goals of the FY2021-2022 HOME-ARP Program  
7 and all applicable legal requirements, and any such actions are solely intended to further the  
8 purposes of this Resolution, and are subject in all respect to the terms of this Resolution, and  
9 any such action cannot increase the risk to the City, or require the City to expend any  
10 resources, and that the Mayor shall consult with the City Attorney prior to execution and  
11 provided that within 30 days of the agreements approved by this Resolution being executed  
12 by all parties, such final documents (showing marked changes, if any) shall be provided to the  
13 Clerk of the Board, for inclusion in the official file, together with a brief explanation of any  
14 actions from the date of the adoption of this Resolution and, be it

15           FURTHER RESOLVED, That all actions heretofore taken by the officers of the City  
16 with respect to the application for, or the acceptance or expenditure of, FY2021-2022 HOME-  
17 ARP funds, as consistent with the documents herein and this Resolution, are hereby  
18 approved, confirmed and ratified.
