BergDavis Public Affairs is submitting this request for a Public Convenience Necessity Resolution on behalf of the project sponsor, Amish Patel with SAKS Bars Inc. Mr. Patel intends to open a small bar in the approximately 1,000-square-foot vacant retail space located at 708 Polk Street, adjacent to the Hotel Epik.

Public Convenience and Necessity

Situated just steps from San Francisco City Hall, Bill Graham Civic Auditorium, War Memorial Opera House, and Davies Symphony Hall, the proposed bar intends to serve the many City residents and tourists that frequent local Civic Center and Tenderloin destinations. The bar will also serve as an amenity for the newly-opened, 84-room Hotel Epik at 706 Polk Street.

Facts About the Proposed Bar

- The hours of operation as proposed are 4:00 p.m. to 2:00 a.m., seven days a week.
- On-site security will be provided during hours of operation, ensuring visitors are respectful of their surroundings. Additionally, interior and exterior cameras will be installed.
- An application for a Type 48 license (on-sale general) has been submitted to the California Department of Alcohol Beverage Control (ABC). The license is being

transferred within District 6, from the recently closed Volta Modern Brasserie at 868 Mission Street.

Outreach

Preliminary discussions with Sergeant Patrick Kennedy, SFPD Alcohol Liaison Unit, and Officer Steve Matthias, SFPD Central Station Alcohol Licensing, were favorable and did not reveal any substantive concerns. The project is supported by Randy Shaw, Tenderloin Housing Clinic and several of the local merchants.

Per the ABC requirements, a notification was mailed to all persons living within a 500' radius of the proposed site. The comment period closed on February 18, 2017 and there were no comments received by the ABC.

Residents that reside within the 500' foot radius were also invited to attend a community meeting on Wednesday, March 8 at 6pm at the SFPD Tenderloin. We also invited Supervisor Kim's office to attend the meeting and offered to provide an in-person project briefing. At the meeting, neighbors had the opportunity meet the project sponsors and architect and ask questions about the project. Over 1,900 invitations were mailed – one community member in support of the project attended the meeting.




