3 **Resolution approving the settlement of the unlitigated claim filed by KHP III SF Sutter**  
4 **LLC against the City and County of San Francisco for \$3,750,000; the claim was filed on**  
5 **January 10, 2023; the claim involves allegations of property damage to the Kimpton**  
6 **Buchanan Hotel caused by shelter-in-place (SIP) hotel guests during the COVID-19**  
7 **pandemic and resulting loss of use; other material terms of the settlement include a**  
8 **mutual full and final release, with each party to bear their own costs.**

10 WHEREAS, KHP III SF Sutter LLC filed Government Code Claim No. 23-01050 on  
11 January 10, 2023 against the City and County of San Francisco (Claim); and

12 WHEREAS, The Claim involves allegations of property damage to the Kimpton  
13 Buchanan Hotel caused by shelter-in-place hotel guests during the COVID-19 pandemic and  
14 resulting loss of use; and

15 WHEREAS, The Human Services Agency has recommended settlement of the Claim  
16 by payment of \$3,750,000 and other material terms of the settlement include a mutual full and  
17 final release, with each party to bear their own costs; now, therefore, be it

18 RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of  
19 Supervisors hereby authorizes the City Attorney to settle and compromise the Claim by  
20 payment of \$3,750,000 and other material terms of the settlement include a mutual full and  
21 final release, with each party to bear their own costs; the Controller is authorized to transfer  
22 appropriated funds between departments to pay the cost of the settlement described herein.
