3 **Resolution designating certain intersections as "STOP" intersections.**

4 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
5 following intersections are hereby designated as "STOP" intersections, and the
6 Department of Parking and Traffic is hereby authorized and directed to cause "STOP"
7 signs to be installed thereat as designated below:

8 **STOP SIGNS - ESTABLISH**

9 Mariposa Street, stopping Mariposa Street at Florida Street, making this
10 intersection an All-Way STOP;

11 Mariposa Street, stopping Mariposa Street at Hampshire Street, making this
12 intersection an All-Way STOP;

13 22nd Street, stopping 22nd Street at Alabama Street, making this intersection an
14 All-Way STOP;

15 Hillway Avenue, stopping Hillway Avenue at Parnassus Avenue, controlling the
16 stem to this T-intersection; and

17 Broderick Street, stopping Broderick Street at Jefferson Street, making this
18 intersection an All-Way STOP.

19 Categorically exempt from Environmental
20 Review Class 1(c)(9) changes in the traffic and
21 parking regulations where such changes do not
22 establish a higher speed limit or result in more
23 than a negligible increase in the use of the
24 street.




