AUTHORIZING AIRPORT COMMISSION TO APPLY FOR, ACCEPT, AND EXPEND GRANT OF \$8,370,743.00 FROM FEDERAL AVIATION ADMINISTRATION FOR ASSISTANCE IN IMPROVEMENTS AT THE AIRPORT (A.I.P. 14: APPLICATION NO. 99-01)

WHEREAS, certain essential improvements which are to be constructed at San Francisco International Airport are eligible for Federal funds under the Airport Improvement Program which provides for the reimbursement by the Federal Aviation Administration of a portion of the allowable project costs; and

WHEREAS, all indirect services provided by the City to the Airport and the Commission are covered in the Annual Service Payment pursuant to the Lease and Use Agreement between the City of San Francisco and the major airlines using San Francisco International Airport, with request for additional reimbursement for indirect services in this grant being prohibited, the requirements of Section 10.170 of the San Francisco Administrative Code are deemed satisfied; now therefore, be it

RESOLVED, that the Airport Commission, which has jurisdiction over the San Francisco International Airport, is hereby authorized to apply for, accept, and expend grant of \$8,370,743.00 (A.I.P. 14: Application No. 99-01), with the Federal Aviation Administration for assistance in the improvement of San Francisco International Airport under the Airport Improvement Program; the projects shall include, the reconstruction and overlay of 5,000 feet of Runway 1R-19L and the as-needed reconstruction and overlay of 4,000 feet of various taxiways, together with all necessary and appurtenant work. The estimated total cost is \$11,160,990.00, of which \$8,370,743.00 is eligible for reimbursement by the Federal Aviation Administration, and any amendments made thereto.
