2 AUTHORIZING THE DEPARTMENT OF THE PUBLIC LIBRARY TO ACCEPT AND EXPEND  
3 A GRANT IN THE AMOUNT OF \$135,469 FROM THE CALIFORNIA STATE LIBRARY  
4 AS PART OF THE FEDERAL LIBRARY SERVICES AND TECHNOLOGY ACT (LSTA) FOR  
5 ESTABLISHING A SCHOOL SERVICES CORPS IN COOPERATION WITH SAN  
6 FRANCISCO UNIFIED SCHOOL DISTRICT.

8 WHEREAS, Many of the Teachers and Students in the 17 Middle  
9 Schools of the San Francisco Unified School District are unaware of  
10 the extensive traditional and electronic resources at the Public  
11 Library that can support their educational needs; and,

12 WHEREAS, The Unified School District has identified traditional  
13 and technology literacy as key to helping students who consistently  
14 score below the national average; and,

15 WHEREAS, The Public Library proposes to increase its  
16 collaborative activities with the School District to help teachers,  
17 school librarians, parents and students to understand and  
18 successfully use the Public Library resources for curriculum  
19 development and homework assignments; and,

20 WHEREAS, Increased cooperation between schools and libraries to  
21 make the best use of educational resources benefits the entire  
22 community; and,

23 WHEREAS, The grant budget includes provision for indirect costs  
24 of \$12,315; now, therefore, be it




