6 WHEREAS, The Chinese Chamber of Commerce is an established non-profit
7 organization known for its steadfast leadership serving the Chinese community; and

8 WHEREAS, The Chinese Chamber of Commerce spearheaded the first ever
9 Chinatown Summer Scrub Down during the month of June 2003 to enhance the Chinatown
10 neighborhood into a more welcoming place for tourism and residential living; and

11 WHEREAS, The Chinese Chamber of Commerce has secured \$55,000 worth of public
12 advertisements to promote and inform the public of the project, and

13 WHEREAS, The Chinese Chamber of Commerce procured materials for the Scrub
14 Down project, such as liquid soap dispensers, toilet seats, paint, and labor donated by
15 Chinese American contractors; and

16 WHEREAS, The Chinese Chamber of Commerce in cooperation with the Departments
17 of Parking and Traffic, Recreation and Park, Public Health, and the Public Utilities
18 Commission, provided repair and maintenance of streets, restrooms, and parks, and renew
19 worn down public property around the neighborhood; and

20 WHEREAS, San Francisco's Chinatown is known throughout the world as a premier
21 tourist destination and contributes greatly to the economic health of the entire Bay Area
22 community; and

23 WHEREAS, Current widespread health concerns have presented significant
24 challenges to business owners in Chinatown; and


