

1 [Traffic Regulations]

2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

6 **BICYCLE LANES - ESTABLISH**

7 8th Street, west curb lane (southbound only), between Market and Bryant Streets

8 Cesar Chavez Street, north curb lane (westbound only), between Vermont Street
9 and northbound U.S. 101 on-ramp

10 Kirkham Street, both curb lanes (eastbound and westbound), between 6th and 9th
Avenues

11 **MID-BLOCK CROSSWALK - ESTABLISH**

12 Terry Francois Boulevard, approximately 750 feet south of Mission Rock Street
13 (just south of Pier 52 Boat Launch)

14 **NO LEFT TURN - RESCIND**

14 **NO LEFT TURN, EXCEPT MUNI - ESTABLISH**

15 Crossover Drive, northbound, at Fulton Street (adds Muni exemption)

16 Fulton Street, westbound, at Park Presidio Boulevard (adds Muni exemption)

17 **NO U-TURNS - RESCIND**

18 Brotherhood Way, westbound, at the entrance to 999 Brotherhood Way

19 **RIGHT LANE MUST TURN RIGHT, EXCEPT BICYCLES - ESTABLISH**

20 Market Street, eastbound, at 10th Street

21 **RIGHT LANE MUST TURN RIGHT, EXCEPT MUNI - ESTABLISH**

22 Euclid Avenue, westbound, at Arguello Boulevard

1 **TOW-AWAY LANE MUST TURN LEFT - ESTABLISH**

2 Sutter Street, westbound, at Mason Street

3 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND**

4 Sutter Street, south side, between Mason and Gough Streets

5 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

6 Brotherhood Way, south side, from driveway at 999 Brotherhood Way to 50 feet
7 easterly (50-foot zone)

8 Cesar Chavez Street, north side, between Kansas and Vermont Streets

9 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY -
ESTABLISH**

10 Market Street, north side, from 126 feet to 206 feet east of Church Street (80-foot
11 zone, eliminates 4 parking spaces during affected days and hours)

BICYCLE LANES - ESTABLISH

8th Street, west curb lane (southbound only), between Market and Bryant Streets
Cesar Chavez Street, north curb lane (westbound only), between Vermont Street and northbound U.S.
101 on-ramp
Kirkham Street, both curb lanes (eastbound and westbound), between 6th and 9th Avenues

MID-BLOCK CROSSWALK - ESTABLISH

Terry Francois Boulevard, approximately 750 feet south of Mission Rock Street (just south of Pier 52 Boat Launch)

NO LEFT TURN - RESCIND

NO LEFT TURN, EXCEPT MUNI - ESTABLISH

Crossover Drive, northbound, at Fulton Street (adds Muni exemption)
Fulton Street, westbound, at Park Presidio Boulevard (adds Muni exemption)

NO U-TURNS - RESCIND

Brotherhood Way, westbound, at the entrance to 999 Brotherhood Way

RIGHT LANE MUST TURN RIGHT, EXCEPT BICYCLES - ESTABLISH

Market Street, eastbound, at 10th Street

RIGHT LANE MUST TURN RIGHT, EXCEPT MUNI - ESTABLISH

Euclid Avenue, westbound, at Arguello Boulevard

TOW-AWAY LANE MUST TURN LEFT - ESTABLISH

Sutter Street, westbound, at Mason Street

TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND

Sutter Street, south side, between Mason and Gough Streets

TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH

Brotherhood Way, south side, from driveway at 999 Brotherhood Way to 50 feet easterly (50-foot zone)
Cesar Chavez Street, north side, between Kansas and Vermont Streets

TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH

Market Street, north side, from 126 feet to 206 feet east of Church Street (80-foot zone, eliminates 4 parking spaces during affected days and hours)




