RESOLUTION NO. 437-22

Resolution responding to the Presiding Judge of the Superior Court on the findings and recommendations contained in the 2021-2022 Civil Grand Jury Report, entitled "Buried Problems and a Buried Process: The Hunters Point Naval Shipyard in a Time of Climate Change;" and urging the Mayor to cause the implementation of accepted findings and recommendations through her department heads and through the development of the annual budget.

WHEREAS, Under California Penal Code, Section 933 et seq., the Board of Supervisors must respond, within 90 days of receipt, to the Presiding Judge of the Superior Court on the findings and recommendations contained in Civil Grand Jury Reports; and

WHEREAS, In accordance with California Penal Code, Section 933.05(c), if a finding or recommendation of the Civil Grand Jury addresses budgetary or personnel matters of a county agency or a department headed by an elected officer, the agency or department head and the Board of Supervisors shall respond if requested by the Civil Grand Jury, but the response of the Board of Supervisors shall address only budgetary or personnel matters over which it has some decision making authority; and

WHEREAS, Under San Francisco Administrative Code, Section 2.10(a), the Board of Supervisors must conduct a public hearing by a committee to consider a final report of the findings and recommendations submitted, and notify the current foreperson and immediate past foreperson of the Civil Grand Jury when such hearing is scheduled; and

WHEREAS, In accordance with San Francisco Administrative Code, Section 2.10(b), the Controller must report to the Board of Supervisors on the implementation of

recommendations that pertain to fiscal matters that were considered at a public hearing held by a Board of Supervisors Committee; and

WHEREAS, The 2021-2022 Civil Grand Jury Report, entitled "Buried Problems and a Buried Process: The Hunters Point Naval Shipyard in a Time of Climate Change" ("Report") is on file with the Clerk of the Board of Supervisors in File No. 220722, which is hereby declared to be a part of this Resolution as if set forth fully herein; and

WHEREAS, The Civil Grand Jury has requested that the Board of Supervisors respond to Finding Nos. F4, F5, and F6, as well as Recommendation Nos. R2, R3, and R7, contained in the subject Report; and

WHEREAS, Finding No. F4 states: "Despite the enormous stakes of the process governing the Shipyard cleanup, there is little understanding of the process throughout the City, or even that the City can influence this process;" and

WHEREAS, Finding No. F5 states: "The City and County of San Francisco is poorly prepared to discover new information pertinent to the Shipyard cleanup, to proactively look for risks and problems overlooked or under-prioritized by the Federal Facility Agreement signatories, or to develop responses to new information or problems;" and

WHEREAS, Finding No. F6 states: "No proactive mechanism exists for the City and County of San Francisco to articulate its interests and concerns about the cleanup for the Federal Facility Agreement signatories, nor does a mechanism exist for the City to monitor progress towards obtaining satisfactory responses to such interests and concerns from the signatories;" and

WHEREAS, Recommendation No. R2 states: "The Mayor and the Board of Supervisors should collaborate to provide funding for the study recommended in R1, in the Fiscal Year 22-23 budget, or by October 1st, 2022;" and

WHEREAS, Recommendation No. R3 states: "By October 1st, 2022, the Board of Supervisors should pass an ordinance to create a permanent Hunters Point Shipyard Cleanup Oversight Committee that includes the Controller or their designee, relevant technical experts from the Public Utilities Commission and the Department of Public Works, and representatives from other relevant City departments, to perform due diligence on behalf of the City and County of San Francisco into the Federal Facility Agreement signatories' decision-making, and to prepare an agenda of questions and requests to be communicated to the signatories by the Department of Public Health in advance of major cleanup document releases;" and

WHEREAS, Recommendation No. R7 states: "By March 1st, 2023, the Hunters Point Shipyard Cleanup Oversight Committee should prepare a report on its recommended requests for the Federal Facility Agreement signatories based on the groundwater study recommended in R1, and deliver that report to the Board of Supervisors, the Mayor, and the Department of Public Health;" and

WHEREAS, In accordance with California Penal Code, Section 933.05(c), the Board of Supervisors must respond, within 90 days of receipt, to the Presiding Judge of the Superior Court on Finding Nos. F4, F5, and F6, as well as Recommendation Nos. R2, R3, and R7 contained in the subject Report; now, therefore, be it

RESOLVED, That the Board of Supervisors reports to the Presiding Judge of the Superior Court that they agree with Finding No. F4 for reason as follows: The report clearly indicates confusion around the Navy's cleanup process and timelines on the Shipyard and the need for more transparency from the Navy; in addition, we find the City and County of San Francisco has very little opportunity to influence the process set forth by the Navy for the Shipyard cleanup as the Navy is federal entity; however, the Office of Community Investment and Infrastructure (OCII), the successor agency to the former San Francisco Redevelopment

Agency, can determine whether or not a transfer of land from the federal government to the City would take place; and, be it

FURTHER RESOLVED, That the Board of Supervisors reports to the Presiding Judge of the Superior Court that they agree with Finding No. F5 for reason as follows: the City and County of San Francisco can most certainly work to increase staffing to adequately address issues and problems that arose on the Shipyard that have been missed by the Federal Facility Agreement signatories; seemingly, a deeper commitment from the City and County of San Francisco to identify additional issues in order to provide responses to new information or new problems is needed; and, be it

FURTHER RESOLVED, That the Board of Supervisors reports to the Presiding Judge of the Superior Court that they partially agree with Finding No. F6 for reason as follows: The Board of Supervisors believes that the establishment of the Bayview Hunters Point Shipyard Citizens Advisory Committee (CAC), along with the consistent meetings with the Navy and Environmental Protection Agency (EPA), demonstrates that a proactive mechanism does exist for the City and County of San Francisco to articulate its interests and concerns about the cleanup for the Federal Facility Agreement signatories; furthermore, the CAC's existence also demonstrates that the City and County of San Francisco understands the importance of community representation, feedback, and participation in ensuring the Shipyard is clean and safe; there is, however, more to be desired in the area of monitoring progress towards satisfactory responses to such interests and concerns from the signatories; and, more effort is required to obtain timely and transparent responses from the Navy and all Federal Facility Agreement signatories; and, be it

FURTHER RESOLVED, That the Board of Supervisors reports that Recommendation No. R2 will be implemented to secure an independent commission and third-party study of the Hunters Point *Shipyard* to predict the future shallow groundwater surface, groundwater flows

and potential interactions of groundwater with hazardous materials and planned modifications to the site under multiple sea level rise scenarios is necessary and we will work to secure the resources for the independent commission and third party study; in addition, the City needs to ensure that the appropriate City employees are attentive and prepared to respond to the issues presented in the report around groundwater and sea level rise, and it may be beneficial for the San Francisco Department of Public Health to assign additional staff to conduct this study and to urge the California Department of Public Health and the federal regulators like the Environmental Protection Agency and the California State Water Resources Control Board do the same; we were not asked by the Civil Grand Jury to respond to recommendation R1, but do agree an independent third-party study is necessary; and, be it

FURTHER RESOLVED, That the Board of Supervisors reports that Recommendation No. R3 will not be implemented because in lieu of creating a permanent oversight committee, the Board of Supervisors will create a short-term oversight committee or task force to develop recommendations to address the findings in the Report; and that understanding the science is on groundwater and sea level rise is important in keeping people safe, as the City is committed to doing; and, be it

FURTHER RESOLVED, That the Board of Supervisors reports that Recommendation No. R7 will not be implemented, however, the Board of Supervisors intends to create a short-term task force within 18 months to develop recommendations to address the findings in the Report and as an independent third-party entity that conducts the study to prepare a report on its recommended request for the Federal Facility Agreement signatories based on its findings and deliver that report to the Board of Supervisors, the Mayor and Department of Public Health; and, be it

FURTHER RESOLVED, That the San Francisco Department of Public Health will be monitoring the indefinite five-year review from the Navy to evaluate the protectiveness of past

remedies, to ensure that their ongoing clean up and solutions remains protective—this process began in 2018; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges the Mayor to cause the implementation of the accepted findings and recommendations through her department heads and through the development of the annual budget.
