7 Francisco resident since 1975, currently residing in Noe Valley; and

8 WHEREAS, Tom is a talented muralist who has been commissioned to produce  
9 artwork for many Bay Area organizations, including Bank of America, Kaiser Hospitals,  
10 Oracle, Montgomery Asset Management, Lindsey Museum, and Macy's; and

11 WHEREAS, Tom's first mural was commissioned by the Western Pacific Railroad in  
12 1977 and subsequently donated to the Railroad Museum in Sacramento in 1984; and

13 WHEREAS, Tom was recently commissioned by the San Francisco Giants to create  
14 six large murals for display at Pac Bell Park, depicting the energy and action of baseball; and

15 WHEREAS These murals, along with his other work, have delighted children, families,  
16 and baseball fans alike, and will continue to do so for thousands of City residents and visitors  
17 in the future;

18 WHEREAS, Tom currently shares his craft with participants in the 1998 Memorial  
19 Charles G. Farr Drawing Class, which has been meeting in San Francisco for over 30 years;  
20 now, therefore be it

21 RESOLVED, that the City and County of San Francisco Board of Supervisors hereby  
22 commends San Francisco Muralist Tom Mogensen for his extraordinary work on the large  
23 murals displayed at Pacific Bell Park and on other murals throughout the state.




