10 WHEREAS, Libby is the founder of the After School Enrichment Program (ASEP), a  
11 non-profit after school child care center at McKinley Elementary School with 120 students,  
12 most whom are attending, at no cost to their families, a \$400,000 annual budget and 14  
13 employees; and

14 WHEREAS, As Executive Director of ASEP, Libby improved other programs by  
15 mentoring other after school site coordinators in San Francisco and serving on the Childcare  
16 Planning and Advisory Council's school-age committee; and

17 WHEREAS, Libby's career as a nutrition expert in San Francisco began in 1984, when  
18 she supervised Centro Latino's Kitchen in the Mission District; and

19 WHEREAS, Her work with 200 family child care providers in the Child and Adult Care  
20 Food Program made all low-income children in San Francisco eligible for a higher rate of  
21 meals reimbursement which is now known in the industry as "Libby's Law"; and

22 WHEREAS, Libby left the Children's Council in 1999 to start After School Enrichment,  
23 and is leaving ASE after six wonderfully successful years to take a position with the  
24 Department of Children, Youth and Their Families; now, therefore, be it

1 RESOLVED, That the San Francisco Board of Supervisors does hereby commend  
2 Libby Albert on all her accomplishments and wishes her continued success in her new  
3 position at the DCYF.


