8 distinguished rabbi for 50 years since his ordination by Hebrew Union College-Jewish Institute
9 of Religion in 1964; and

10 WHEREAS, Rabbi Martin S. Weiner made notable contributions to the spiritual life of
11 Temple Oheb Shalom in Baltimore from 1964-1972 and as senior rabbi at Congregation
12 Sherith Isreal in San Francisco from 1972-2003; and

13 WHEREAS, Rabbi Martin S. Weiner earned the accolade of "rabbi's rabbi" through his
14 work inspiring his congregation, his encouragement of young congregants to enter the
15 rabbinate, and his many activities engaged in the pursuit of social justice and human rights;

17 WHEREAS, Rabbi Martin S. Weiner provided outstanding leadership to the North
18 American Reform Jewish movement as Vice President and then as President of the Central
19 Conference of American Rabbis; now, therefore, be it
