2 AUTHORIZING THE CHIEF OF POLICE OF THE SAN FRANCISCO POLICE
3 DEPARTMENT TO ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF \$100,000
4 FROM THE DEPARTMENT OF ALCOHOL BEVERAGE CONTROL FOR GRANT ASSISTANCE
5 TO LOCAL LAW ENFORCEMENT AGENCIES PROJECT AND THE GRANT TERMS
6 PROHIBIT INCLUDING INDIRECT COSTS.

8 WHEREAS, the Chief of Police of the City and County of San
9 Francisco is authorized to undertake a certain project designated
10 "2000/2001 Grant Assistance to Local Law Enforcement Agencies
11 Project" to be funded by funds made available through the California
12 Department of Alcohol Beverage Control (herein after referred to as
13 "ABC") for the reduction in crime in on-sale and off-sale premises
14 which operate in a disorderly and disruptive manner; and,

15 RESOLVED, that the Chief of Police of the City and County
16 of San Francisco is authorized on behalf of the City and County of
17 San Francisco to accept and expend funding for this project from ABC,
18 and the grant terms prohibit including indirect costs; and,

19 FURTHER RESOLVED, that the Chief of Police of the City and
20 County of San Francisco is authorized to execute on behalf of the
21 City and County of San Francisco the necessary Grant Award Agreement
22 for this project including any augmentations from ABC, extensions and
23 amendments thereof, and be it


24 FURTHER RESOLVED, that the board of supervisors hereby waives

5 responsibility for and such liability; and be it


6 FURTHER RESOLVED, those grants funds received hereunder shall




