Resolution reaffirming approval of the CleanPowerSF Updated 2015 Implementation Plan and Statement of Intent for community choice aggregation program, including modifications consistent with the 2015 Implementation Plan.

WHEREAS, In 2004, the Board of Supervisors unanimously established a Community Choice Aggregation (CCA) program (Ordinance No. 86-04), now called CleanPowerSF in accordance with California Public Utilities Code, Sections 218.3, 331.1, 366, 366.2, 381.1, 394, and 394.25, allowing San Francisco to aggregate the electrical load of consumers within San Francisco and to accelerate the use of renewable energy, conservation and energy efficiency in San Francisco; and

WHEREAS, In 2007, the Board of Supervisors adopted a CCA Program Description, Revenue Bond Action Plan, and Draft Implementation Plan (Ordinance No. 147-07); and

WHEREAS, In 2009, the Board of Supervisors found further approvals necessary to effectuate Ordinances 86-04, 146-07, 147-07, and 232-09 and could be made by Resolution to the extent otherwise permitted by law (Ordinance No. 232-09); and

WHEREAS, In 2010 the Board of Supervisors adopted a Draft Implementation Plan and authorized the General Manager of the San Francisco Public Utilities Commission (PUC) to file with the California Public Utilities Commission (CPUC) an implementation plan consistent with that ordinance (Ordinance No. 45-10); and

WHEREAS, The PUC submitted previous versions of the implementation plan to CPUC on March 3, 2010, and November 12, 2012; and

WHEREAS, CPUC approved these previous versions of the implementation plan on May 18, 2010, and June 7, 2012; and

WHEREAS, The PUC has recently made changes to CleanPowerSF resulting in the need to update the 2012 Implementation Plan; and

WHEREAS On July 14, 2015, the PUC approved the Updated 2015 Implementation Plan and Statement of Intent (PUC Resolution No.15-0159); now, therefore, be it

RESOLVED, The Board of Supervisors reaffirms its approval of the CleanPowerSF Implementation Plan, including changes consistent with the Updated 2015 Implementation Plan.
