7 became a Deputy District Attorney in Alameda County where she worked for eight years; and

8 WHEREAS; Kamala Harris, as Deputy District Attorney, created San Francisco's first
9 prosecution team to exclusively handle child assault cases; and

10 WHEREAS; Kamala Harris helped found San Francisco's first Safe House for sexually
11 exploited youth; and

12 WHEREAS; Kamala Harris sponsored statewide legislation to toughen punishment for
13 child sex predators; and

14 WHEREAS; From 1998 to 2000, Kamala Harris became the Managing Attorney in the
15 Career Criminal Unit for the Office of the San Francisco District Attorney; and

16 WHEREAS; From 2000 to 2003, Kamala Harris became the Chief of the Community
17 and Neighborhood Division for the Office of the San Francisco District Attorney; and

18 WHEREAS; In 2003, Kamala Harris was elected as San Francisco's District Attorney;
19 and

20 WHEREAS; In 2006, Kamala Harris was elected to the National District Attorneys
21 Association's Board of Directors and selected to Co-Chair the Corrections and Re-Entry
22 Committee; and

23 WHEREAS; Kamala Harris has shown career-long dedication to the city and citizens of
24 San Francisco; now, therefore, be it
