10 alcoholic beverage control license for R.J.'s Market located at 1425 Sansome Street;

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San
18 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
19 off-sale general alcoholic beverage control license from 725 Folsom Street to 1425
20 Sansome Street (District 3) for Radovan Pesusic for R.J.'s Market, will serve the public
21 convenience and necessity of the people of the City and County of San Francisco.

22 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only
23 between the hours of 7:00 a.m. and 8:00 p.m. each day of the week. (2) The petitioner
24 shall be responsible for maintaining free of litter the area adjacent to the premises over
25 which they have control.




