3 **Ordinance making environmental findings and amending the San Francisco Park Code,**
4 **Article 12, by amending Sec. 12.20 to authorize an annual cost of living increase in golf**
5 **fees; and adding Sec. 12.37 to establish fees for Gleneagles Course at McLaren Park.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this
12 Ordinance are in compliance with the California Environmental Quality Act (California Public
13 Resources Code sections 21000 et seq.).

14 Section 2. The San Francisco Park Code is hereby amended by amending Section
15 12.20, to read as follows:

16 Sec. 12.20. ADJUSTMENT OF FEES.

17 (a) Beginning with fiscal year 2003-2004, fees set forth in this Article 12, unless
18 otherwise specified, may be adjusted each year, without further action by the Board of
19 Supervisors, to reflect changes in the relevant Consumer Price Index (CPI), as determined by
20 the Controller.

21 No later than April 15th of each year, the Recreation and Parks Department shall
22 submit its current fee schedule to the Controller, who shall apply the price index adjustment to
23 produce a new fee schedule for the following year.

24 No later than May 15th of each year, the Controller shall file a report with the Board of
25 Supervisors reporting the new fee schedule and certifying that: (a) the fees produce sufficient

1 revenue to support the costs of providing the services for which each fee is assessed, and (b)
2 the fees do not produce revenue which is significantly more than the costs of providing the
3 services for which each fee is assessed.

4 (b) All golf fees for San Francisco residents, juniors, seniors may be increased annually by the
5 CPI, or up to \$1.00, whichever is greater, upon approval of the Recreation and Park Commission. All
6 golf fees for non S. F. residents and tournaments may be increased by two times (2x) the CPI, or up to
7 \$1.00, whichever is greater, upon approval of the Recreation and Park Commission.

8 Section 3. The San Francisco Park Code is hereby amended by adding Section 12.37,
9 to read as follows:

10 Sec. 12.37. GOLF FEES – MCLAREN PARK (GLENEAGLES).

11 The following fees shall be charged for golfing at McLaren Park:

<u>(a) Nine Holes</u>	<u>Weekday (Mon – Thurs)</u>	<u>Weekend (Fri – Sun.)</u>
<u>(1) Standard</u>	<u>\$13.00</u>	<u>\$16.00</u>
<u>(2) Senior</u>	<u>\$09.00</u>	
<u>(b) Eighteen Holes</u>	<u>Weekday (Mon – Thurs)</u>	<u>Weekend (Fri – Sun.)</u>
<u>(1) Standard</u>	<u>\$20.00</u>	<u>\$27.00</u>
