- 5. Appoints the General Manager or Acting General Manager as agent of the Recreation and Park Department to conduct all negotiations, execute and submit all documents, including but not limited to, applications, agreements, payment requests and so on, which may be necessary for the completion of the aforementioned projects; and
- 6. Waives indirect costs as they are not allowed by the Funder.
