WHEREAS, The bid of Salomon Smith Barney is the bid for the Bonds, taking into consideration the interest rates and premium, if any, specified therein, that represents the lowest true interest cost to the City; now, therefore be it

MOVED, By the Finance Committee of the Board of Supervisors of the City and County of San Francisco, as follows:

1. The bid of Salomon Smith Barney for the Bonds is hereby accepted, and the Treasurer of the City and County of San Francisco is hereby authorized and directed to deliver the Bonds to Salomon Smith Barney upon payment to the Treasurer of the purchase price of \$ 97,879,567.90 together with accrued interest to the date of delivery.

The Bonds will mature and bear interest as set forth in Appendix A hereto.

The Bonds shall bear interest from June 15, 1999 at the foregoing rates, payable on December 15, 1999, and semiannually thereafter on June 15 and December 15 in each year.

2. All bids except the bid of Salomon Smith Barney are hereby rejected.
