5 WHEREAS, the San Francisco Asthma Task Force has completed and has made
6 significant headway in the implementation of the Strategic Plan on Asthma for the City and
7 County of San Francisco on May 2003, which contains recommendations for legislative action
8 and city-wide strategies to manage and prevent asthma in the City and County of San
9 Francisco; and,

11 WHEREAS, the Asthma Task Force garnered further recognition and support for its
12 policy advocacy work with an annual General Fund allocation from the City and County of
13 San Francisco for the past three years, as granted recognition by receiving Community
14 Benefits Awards from California Pacific Medical Center and Kaiser Permanente to further
15 promote and advance systemic changes surrounding asthma; and,

17 WHEREAS, significant policy changes have been adopted by the San Francisco
18 Unified School District and a strong partnership has been created with the San Francisco
19 Housing Authority, leading to instrumental successes in the fight against asthma and a
20 positive impact upon children and adults with asthma in San Francisco; and,

22 WHEREAS, the Asthma Task Force is well immersed in the implementation process of
23 the Strategic Plan on Asthma, but needs additional time to further follow-up on
24 recommendations and policies passed to ensure their proper implementation and future
25 sustainability; and,


